## SUPPLEMENTAL ORDER

Applicants, under date of April 21, 1949, having requested in writing that Decision No. 42696. dated April 12, 1949, in this proceeding, be supplemented and amended in certain minor respects, and good cause appearing,

IT IS HEREBY ORDERED that said Devision be supplemented to include the following language:

(1) The certificate of public convenience and necessity granted to Los Angeles Transit Lings pursuant to Paragraph III of the above Order shall be consolidated with and made part of the operative rights heretofore issued by Decision No. 27052, dated May 14, 1934, on Application No. 19179, and decisions supplementary thereto and amendatory thereof.

Applicant, Los Angeles Transit Lines, is authorized to turn its motor coaches at termini and intermediate points, in either direction, at intersections of streets or by operating around a block contiguous to such intersection, or in accordance with local traffic rules.

(2) The certificate of public convenience and necessity granted to Pacific Electric Railway Company pursuant to Paragraph IV of said Decision shall be consolidated with and made part of the operative rights created by Decision No. 38827, dated April 9, 1946. on Application No. 26636, and decisions supplemental thereto and amendatory thereof.

Applicant, Pacific Electric Railway Company, is authorized to turn its motor coaches at termini and intermediate points, in either direction, at intersections of streets or by operating around a block contiguous to such intersection, or in accordance with local traffic rules.

IT IS HEREBY FURTHER ORDERED that Paragraph VI of said Order be amended to read as follows:

VI. All existing certificates of public convenience and necessity heretofore issued to Pacific Electric Railway Company and Los Angeles Transit Lines jointly, under the name of Los Angeles Motor Coach Lines, including those specifically described in Exhibit "A" attached to the application, are revoked and annulled and of no further force and effect. In all other respects Decision No. 42696 shall remain

in full force and effect.

The effective date of this Order shall be twenty (20) days after the date hereof.
