<u>O P I N I O N</u>

Frank Globin, owner and operator of a public utility water system, by the above-entitled application filed March 15, 1950, requests an order of the Commission authorizing a change in the time of payment of charges for seasonal water service furnished to the customers located in and in the vicinity of Al Tahoe, on the south shore of Lake Tahoe, California. A public hearing on this application was held before Examiner Edwards on June 1, 1950, at Globin's Hotel, Al Tahoe, California. At this hearing, applicant requested amendment of the application to provide for a restatement of rate schedules on summer and winter bases and to provide for fire hydrant and week-end service.

The basic request of applicant is for authority to bill for summer season service in one payment in advance on May 1 each year instead of in two payments, as at present, on May 1 and July 1 of each year. Applicant also requested the following changes: To restate the present service rates in the form of summer and winter rates, with the winter rate seasonal payment due November 1 each year,

but with no change in the total annual level of charges; to provide for a \$10 charge for occasional winter week-end use on temporary basis after customer has paid the summer seasonal charge; to provide a \$5 monthly rental charge for each fire hydrant; and to add a charge of \$20 per each family unit in motels or hotels between the present block rates of \$30 and \$15 per unit.

Applicant's system for production and distribution of water consists of two reservoirs, approximately 3 miles of 10-inch transmission main, and a system of distribution pipes, to serve approximately 125 customers. Water is diverted from Trout Creek above the service area into a 9,000,000-gallon reservoir of earthen construction on one bank of the creek. A larger earthen reservoir of 50,000,000gallon capacity has been excavated on the hillside one-half mile below the first reservoir, and water flows from the smaller reservoir to the larger reservoir in an open ditch. Water progresses through the reservoirs very slowly and gives ample time for silt and fine, suspended matter to settle out of the water during the heavy runoff season. Nearly all of the service is rendered to summer cabins, homes, or resort businesses with only some 10% of the customers desiring full winter service. Other customers desire only week-end service during the winter months.

In substantiation of need for these changes, applicant testified as to the difficulty of collecting the summer flat rates in two payments. Those residents who take their vacation early in the year are difficult to reach after the first of July. Similarly, those who take vacations late in the summer are difficult to reach in May. Permission to collect the total seasonal charge in one payment should help reduce losses. Applicant also testified that during the past two years the operations have shown a loss; however, at this time a general system-wide rate increase is not being sought. The present year-round

rates provide for payment on July 1 and January 1. A change in these payment dates to May 1 and November 1, with a change to summer and winter seasonal rates, should lower the cost of making collections.

The local fire district requested the utility to install 10 fire hydrants at various points in the service area. Mr. Globin testified that he has installed an S-inch main, at an expense of \$22,000, from which these hydrants will be served. Applicant proposes a rate of \$5 per month per hydrant for this special service, which is the same rate as is being charged in Carson City and Reno. The district has agreed to the \$5 rate. The hydrants were purchased and furnished by the district, together with an advance of \$50 per hydrant toward the utility's cost of connection.

Several customers appeared at the hearing and furnished statements for the record. The water service is of first quality, and none objected to the proposal to collect the full summer charge in advance or to the other rate requests of the applicant.

In analyzing the record in this proceeding and in reaching a conclusion as to the rates for the future, we are of the opinion that the present request of applicant is reasonable and should be granted. Applicant's proposal will not result in any increase in rates to the majority of the customers. The change in the motel rate may result in a small increase where more than three units are involved. The winter week-end rate provides a reduction from that portion of the present year-round rate which is applicable to winter service. Fire hydrant service is a new rate and does not involve any increase to existing customers.

IT IS HEREBY FOUND AS A FACT that the increases in rates and charges authorized herein are justified; therefore,

IT IS HEREBY ORDERED as follows:

- 1. Applicant is authorized to file in quadruplicate with this Commission after the effective date of this order, in conformity with General Order No. 96, the schedule of rates and conditions shown in Exhibit A attached hereto, and, after not less than five (5) days' notice to the Commission and the public, to make said rates and conditions effective for service rendered on and after July 15, 1950.
- 2. Applicant, within forty (40) days from the effective date of this order, shall file with this Commission four sets of rules and regulations governing customer relations, each set of which shall contain a suitable map or sketch, drawn to an indicated scale upon a sheet 8½ x 11 inches in size, delineating thereupon by distinctive markings the boundary of applicant's present service area and the location thereof with reference to the immediate surrounding territory, provided, however, that such filing shall not be construed as a final or conclusive determination or establishment of the dedicated area of service or portion thereof.
- 3. Applicant, within forty (40) days after the effective date of this order, shall file four copies of a comprehensive map, drawn to an indicated scale of not less than 400 feet to the inch, delineating by appropriate markings the various tracts of land and territory served and the location of various properties of applicant.
