O P I N I O N

Applicant is a certificated passenger stage corporation operating in Oxnard and vicinity (Decision No. 43678).

By this application, authority is sought to make a minor route change in the downtown portion of its Oxnard-Silver Strand Beach Route. At present the route is operated, outbound, westerly from applicant's terminal in the city of Oxnard, along 4th Street to C Street, thence southerly on C to 5th Street, continuing along 5th Street and other named streets to Silver Strand Beach, and return via same route to intersection of A Street and 4th Street. It is proposed to route this line, outbound, from the city terminal, southerly along A Street to 5th Street, thence westerly along 5th Street and continuing along the present route to Silver Strand Beach. On the return trip applicant will operate along the present route to C Street, thence southerly along C Street to 6th Street, thence along 6th Street, A Street, 3rd Street, Oxnard Boulevard, and 4th Street to point of beginning.

Applicant states that the route change is necessary to provide a more adequate service due to recent developments in Oxnard residential and business areas.

The application is not opposed by the city nor does it affect other public carriers. No fare or material schedule changes are contemplated.

Having fully considered this matter, we are of the opinion and find that public convenience and necessity require that the application be granted.

A public hearing is not necessary.

O R D E R

Application having been made, the Commission being fully advised in the premises, and having found that public convenience and necessity so require,

IT IS ORDERED:

(1) That the description of the "Oxnard-Silver Strand Beach Route via Hollywood Beach" appearing in page 5 of Decision No. 43678, dated January 10, 1950, be, and it hereby is, amended to read as follows:

Beginning at applicant's terminus in the City of Oxnard, thence along 4th Street, A Street, 5th Street, Ventura Road, Oxnard Road, Ocean Drive to Silver Strand Beach and return via same route to the intersection of 5th Street and C Street, thence along C Street, 6th Street, A Street, 3rd Street, Oxnard Boulevard, 4th Street to point of beginning.

(2) That, except as herein authorized, Decision No. 43678 shall remain in full force and effect.

The effective date of this order shall be twenty (20) days after the date hereof.
