O P I N I O N

Applicant, Bay Rapid Transit Company, presently rendering a passenger stage service in the City of Monterey and area adjacent thereto, requests authority to extend two of its routes.

By Decision No. 41034, in Application No. 24498, applicant was authorized to serve between Monterey and Carmel. The Monterey terminus of this route is one block from the United States Navy Post Graduate School. Applicant requests authority to extend its route into the school property. Attached to the application and incorporated by reference is a letter written by the Commanding Officer of the Naval School, favoring the proposed extension. According to the Commanding Officer there are presently four hundred civilian and enlisted personnel assigned to the school. Of this number twenty per cent depend upon commercial transportation. To avail themselves of the existing service it is necessary to walk a considerable distance.

In the decision hereinabove referred to, applicant was also authorized to operate over the following route: Hilby Avenue, Noche Buena Avenue, Broadway and Fremont Street. Applicant proposes to extend this route along Noche Buena Avenue to Phoenix Avenue and thence to Fremont Street. Applicant alleges that the area covered by this extension has experienced a vast increase in

population and is in need of the proposed service.

No common carrier is operating over the proposed extended routes.

After full consideration of the facts, we conclude that public convenience and necessity require the establishment of the service as proposed. The application will be granted by amending the affected route descriptions in Decision No. 41034. No public hearing is necessary.

O R D E R

Application having been made as above entitled, and it having been found that public convenience and necessity so require,

IT IS ORDERED:

- (1) That the route described in Decision No. 41034, in Application No. 24498, pages 2 and 3, ordering paragraph number (2) is hereby amended to read as follows:

"Between Monterey and Carmel: Beginning at the United States Naval School thence via military road to Fifth Street and Sloat Avenue entrance to said Naval School, thence along Fifth Street, Ocean Avenue, Del Monte Avenue, Tyler Street, Cass Street, Coast Highway, Camino Del Monte at Carmel Woods, Ocean Avenue, Camino Real, Ninth Avenue, Carmelo Avenue, Santa Lucia Avenue, San Carlos Street, Seventh Avenue, Lincoln Street, Sixth Avenue to its intersection with Camino Del Monte in Carmel."

- (2) That the route description in Decision No. 41034, in Application No. 24498, page 3, ordering paragraph (5), is hereby amended to read as follows:

"Beginning at the intersection of Fremont Street and Hilby Avenue, thence along Hilby Avenue, Noche Buena Avenue, Phoenix Avenue, Fremont Street to its intersection with Hilby Avenue."

The effective date of this order shall be twenty (20) days after the date hereof.
