FIRST SUPPLEMENTAL ORDER

By Decision No. 44656 rendered in this proceeding on August 15, 1950, the applicant, San Diego Transit System, a passenger stage corporation, was authorized purportedly to modify its Route "R" bus line operations. Through inadvertence the new route described in this decision was the route over which applicant theretofore had operated rather than the new route sought to be established. To remedy this error, the decision will be modified so as to embody the proper description.

Now therefore, good cause appearing,

IT IS ORDERED:

(1) That the description of Route "R" appearing in the order in Decision No. 42570, on Application No. 30041 (rendered March 1, 1940), in paragraphs (2) and (4) thereof, and also appearing in said Decision No. 44656, be and it hereby is amended to read as follows:

Beginning at the intersection of Front Street and Broadway; thence along Front Street, E Street, Fourth Avenue, Plaza Street, Third Avenue, E Street, First Avenue, Broadway, Pacific Highway, Barnett Avenue, Midway Drive, Ventura Boulevard, Mission Boulevard, Turquoise Street, La Jolla Boulevard, Pearl Street, Girard Avenue, Wall Street, Ivanhoe Avenue and Silverado Street to Girard Avenue.

Also, beginning at the intersection of Silverado Street and Ivanhoe Avenue; thence along Ivanhoe Avenue, Torrey Pines Road, La Jolla Shores Drive, Camino del Collado, Paseo del Ocaso and Paseo Dorado to La Jolla Shores Drive.

Also, beginning at the intersection of Midway Drive and West Point Loma Boulevard; thence along West Point Loma Boulevard to Cable Street.

Also, beginning at the intersection of Mission Boulevard and Ventura Boulevard; thence along Mission Boulevard to Anacapa Court.

(2) That said Decision No. 44656, rendered herein on August 15, 1950, be and it hereby is modified accordingly. In all other respects said Decisions Nos. 44656 and 42570 shall remain in full force and effect.

This order shall become effective as of the date hereof.
