<u>O P I N I O N</u>

Applicant operates a passenger stage service in Monterey, Pacific Grove and Carmel, and in this application requests permission to alter one of its presently authorized routes in the matter hereinafter described.

Pursuant to Decision No. 44463, in Application No. 31475, applicant was authorized to serve over the following route:

"Between Monterey and Carmel: Beginning at the United States Naval School thence via military road to Fifth Street and Sloat Avenue entrance to said Naval School, thence along Fifth Street, Ocean Avenue, Del Monte Avenue, Tyler Street, Cass Street, Coast Highway, Camino Del Monte at Carmel Woods, Ocean Avenue, Camino Real, Ninth Avenue, Carmelo Avenue, Santa Lucia Avenue, San Carlos Street, Seventh Avenue, Lincoln Street, Sixth Avenue to its intersection with Camino Del Monte in Carmel."

Applicant states that the residents along these streets have requested the proposed rerouting so that they will have service closer to their homes. The change can be made to accommodate these persons without affecting service to other points on the route and will result in substantial convenience to them.

It appears that the proposed rerouting is in the public interest and the application will be granted by amending the effective route description in Decision No. 44463. The matter does not require a public hearing.

IT IS ORDERED:

(1) That the route described in Decision No. 44463 in Application No. 31475, Page 2, ordering paragraph number (1), is hereby amended to read as follows:

> "Beginning at the United States Naval School thence via military road to Fifth and Sloat Street entrance to said Naval School, thence along Sloat Avenue, Seventh Street, Ocean Avenue, Del Monte Avenue, Tyler Street, Cass Street, Coast Highway, Del Monte at Carmel Woods, Ocean Avenue, Camino Real, Ninth Avenue, Carmelo Avenue, Santa Lucia Avenue, San Carlos Street, Seventh Avenue, Lincoln Street, Sixth Avenue to its intersection with Camino Del Monte in Carmel."

In all other respects the order in said Decision No. 44463 shall remain unchanged.

The effective date of this order shall be 20 days after the date hereof.
