In the Matter of the Application of ) SAN DIEGO TRANSIT SYSTEM, a corpora-) tion, for amendment to existing certificates of public convenience and necessity covering its Route "F" > Application No. 32077 and Route "G" bus lines to permit > the rerouting of said lines from ) Sixth Avenue to Fifth Avenue in the ) downtown business section, City of San Diego.

## <u>opinion</u>

By this application, authority is sought to change a loop operation in the business section of San Diego now used for applicant's Route G and Route F lines, as set forth in Decisions Nos. 37737 and 40900, respectively.

The loop is now operated from the intersection of Market Street and Sixth Avenue, along Market Street and Fourth Avenue. E Street and Sixth Avenue, continuing to point of beginning. Because of the congestion and other traffic conditions at the intersection of E Street and Sixth Avenue and the intersection of Market Street and Sixth Avenue, and because there is no signal at the latter intersection to protect the present turn onto Market Street from Sixth Avenue, it is deemed desirable by applicant, and it is alleged, also by the traffic officers of the San Diego Police Department, to reroute said loop operation along Fifth Avenue between E Street and Market Street.

As the proposed route change for said lines appears to be in the public interest, the Commission finds the public convenience and necessity require that the application be granted. No hearing is necessary.

## ORDER

Application having been made therefor, the Commission being fully advised in the premises and having found that public convenience and necessity so require,

IT IS ORDERED:

(1) That the route description of Route G appearing in the order in Decision No. 37737, on Application No. 26570, be, and the same hereby is, amended to read as follows:

## Route G

Commencing at the intersection of Fifth Avenue and Market Street; thence along Market Street to Fourth Avenue; thence along Fourth Avenue to E Street; thence along E Street to Fifth Avenue; thence along Fifth Avenue to Market Street; thence along Market Street, 32nd Street, and Imperial Avenue to 69th Street.

(2) That the route description of Route F appearing in the order in Decision No. 40900, on Application No. 28229, be, and the same hereby is, amended to read as follows:

## Route F

Commencing at the intersection of Fifth Avenue and Market Street; thence along Market Street to Fourth Avenue; thence along Fourth Avenue to E Street; thence along E Street to Fifth Avenue; thence along Fifth Avenue to Market Street; thence along Market Street, 32nd Street, and Imperial Avenue to 69th Street in the City of San Diego; thence via Lisbon Street, Jamacha Road, Glencoe Drive, Canton Drive, Englewood Drive, Alton Drive, Cypress Street, Imperial Avenue, Palm Avenue to La Mesa Boulevard in the City of La Mesa.

(3) That applicant shall give not less than ten (10) days notice of said route changes by posting plainly visible notices at terminals of said lines and on all buses used in the operation of said services.

The effective date of this order shall be twenty (20) days after the date hereof.
