## THIRD SUPPLEMENTAL OPINION AND ORDER

By Decision No. 43778, dated February 7, 1950, the Commission renewed the license of Ernest E. Stubblefield to engage in the business of a motor transportation broker. The license expired December 31, 1950, and is renewable subject to the provisions prescribed by the Commission.

Stubblefield has now filed an application requesting renewal of his license at the same address and for authority to represent three additional carriers. He has also advised the Commission in writing that he desires to terminate the brokerage authority heretofore conferred upon him by two other carriers.

After full consideration of applicant's request, it appears that the license should be renewed and that authority should be granted to serve the additional carriers. A public hearing is not deemed necessary.

Therefore, good cause appearing, IT IS ORDERED that the application of Ernest E. Stubblefield for renewal of his license as a motor transportation broker, as defined in Chapter 705, Statutes of 1935, be and the same is hereby granted, subject to the following conditions:

1. That said licensec shall keep his license certificate as a motor transportation broker posted at his authorized place of business so that it is readily available to public inspection at all times.

2. That said licensee shall do business as a motor transportation broker only at 228 Wholesale Terminal Building, 1304 East Seventh Street, Los Angeles 21, California, until otherwise authorized by the Commission, and for motor carriers hereinafter named, or for whom he may hereafter from time to time be permitted to do business by any subsequent order or orders of the Commission.

IT IS FURTHER CRDERED that the license of said applicant shall authorize him to sell, offer for sale, negotiate for, furnish, or provide transportation of property over the public highways of this State to be furnished only by the carriers whose names, addresses and permit numbers follow, to-wit:
