ORDER INCORPORATING APPLICANT'S THIRD AMENDED APPLICATION IN THE RECORD

In this proceeding, applicant seeks authority to increase its fares and to reroute and extend certain of its lines. At the conclusion of public hearings had at San Jose on January 18 and 19, 1951, before Commissioner Potter and Examiner Mulgrew, the matter was submitted.

By verified amended application, filed March 12, 1951, applicant asks that increased wage rates and costs experienced since the matter was submitted, as well as the effect of these increases on

its over-all costs and operating results, be incorporated in the record and considered by the Commission in disposing of the matter. The amended application shows that the wages of applicant's drivers and shop employees have been raised by 8 cents per hour and that the estimated annual expense resulting from this wage increase amounts to \$23,490 under applicant's present routing arrangements and \$25,248 under the proposed extensions. This information is set forth in detail in an exhibit attached to the amended application. Applicant does not seek any further increase in its fares other than those requested at the hearing.

It appearing that the public interest will be served by admitting the above-described filing and the information therein contained in the record,

entitled application be and it is hereby set aside; that applicant's third amended application and the exhibit attached thereto be and they are hereby incorporated in the record; that the Secretary be and he is hereby directed to cause a certified copy of this order to be served forthwith upon each of the appearances of record in the matter; and that the proceeding shall thereupon stand resubmitted.
