OFINION

applicants herein are highway carriers operating under the authority of permits issued by this Commission. They are engaged in transporting property for Southern California Freight Lines, a highway common and a highway contract carrier. In performing such transportation services they make delivery of C.O.D. (collect on delivery) shipments. Under the provisions of General Order No. 84B, as smended, they are required to file with the Commission bonds of not less than \$2,000 as sureties for the remission of C.O.D. collections. They seek exemption from these bonding requirements.

Public hearing of the matters involved was held before Examiner Abernathy at Los Angeles on April 20, 1951. Evidence was submitted by Charles H. Adams, one of the applicants, and by a representative of Southern California Freight Lines.

Applicant Adams testified that he serves Southern California Freight Lines under contract and has so served that carrier exclusively for about five years. His services consist of picking up shipments in Los Angeles and delivering them along a regular route between Los Angeles and Riverside. He said that the operations of other of the applicants in this proceeding are conducted in a manner generally similar to his.

The witness for Southern California Freight Lines testified that he is acquainted with all of the applicants in this proceeding and that they all operate under exclusive contracts with his company. According to the witness, applicants serve his company as agents; they have no direct contact with shippers except as is necessarily incidental to the transportation of freight which has been tendered to Southern California Freight Lines for shipment. He declared that his company accepts full responsibility for the property transported in its behalf by applicants. He testified further that shippers tendering C.O.D. shipments to Southern California Freight Lines are protected by a surety bond which his company has on file with the Commission in conformity with the provisions of General Order No. 84B. Cargo insurance, public liability and property damage insurance carried by Southern Califormia Freight Lines for itself and for its agent carriers also provide protection for shippers and other members of the public.

The bonding provisions of General Order No. 84B were established primarily for the benefit of shippers. Since it is

The witness submitted as an exhibit a statement signed by 39 of the other applicants authorizing him to appear in their behalf also. The total number of the applicants herein is 56.

Whether or not the applicants are properly authorized to transport property over regular routes is a matter not in issue in this proceeding. Nothing in this opinion nor in the order which follows is to be construed as determinative of operative requirements or authorities.

clear that the shippers of the property handled by applicants are protected by the surety bond filed by Southern California Freight Lines, it appears that bonding of applicants is not necessary. The Commission is of the opinion and finds that the sought exemptions are justified. The application will be granted.

Because the conditions under which the authority herein granted may change at any time, the exemptions will be limited to a one-year period and made subject to an earlier cancellation, change, or extension as circumstances may require. The authority will extend only to shipments handled by applicants for Southern California Freight Lines. Should applicants desire to handle C.O.D. shipments for anyone else, they will be expected to comply with all of the provisions of General Order No. 84c.

It appears from the Commission's records that four of the applicants in this proceeding have discontinued operations since the application was filed on December 21, 1950. The authority which is granted by the order which follows will apply only to the applicants having operating permits in effect at the time of the hearing herein.

ORDER

Public hearing having been held in the above proceeding, and based upon the conclusions and findings in the preceding opinion

IT IS HEREBY ORDERED that the applicants named in Appendix "A" attached hereto, and by this reference made a part hereof, be and they are hereby authorized to transport C.O.D.

On December 1, 1949, General Order No. 84B was superseded by General Order No. 84C of similar effect. The order herein will authorize exemption from the bonding requirements of General Order No.84C.
