FIRST SUPPLEMENTAL ORDER

By Decision No. 38450, dated November 27, 1945, the Commission ordered certain Class I highway contract carriers and radial highway common carriers to file annual reports. The first ordering paragraph of the order in that decision reads as follows:

"IT IS HEREBY ORDERED that Class I highway contract carriers and Class I radial highway common carriers who have average annual operating revenues of \$100,000 or more from motor carrier operations under permits granted pursuant to the provisions of the Highway Carriers Act and who do not file annual reports as highway common carriers be, and they hereby are, ordered and directed, for the year 1945 and subsequent years, to file with the Commission annual reports in such form and at such times as the Commission will hereafter specify."

By its decision entered today in Case No. 4713 and Case No. 4967, the Commission amended the uniform systems of accounts prescribed for Class I carriers so as to define such carriers as those having average gross operating revenues (including interstate and intrastate) of \$200,000 or more annually instead of \$100,000 as previously specified.

It appears to the Commission that it is desirable for the purposes of uniformity to amend the order in Decision No. 38450 so as to conform with the amended uniform systems of accounts; therefore,

IT IS HEREBY ORDERED as follows:

1. The first ordering paragraph of the order in Decision No. 38450, dated November 27, 1945, is amended to read as follows:

"IT IS HEREBY ORDERED that Class I and Class II highway contract carriers and Class I and Class II radial highway common carriers who have average annual operating revenues of \$100,000 or more from motor carrier operations under permits granted pursuant to the provisions of the Highway Carriers' Act and who do not file annual reports as highway common carriers, ^{bc} and they hereby are, ordered and directed, for the year ~~1949~~ ¹⁹⁵⁰ and subsequent years, to file with the Commission annual reports in such form and at such times as the Commission will hereafter specify."

2. In other respects, the order in Decision No. 38450, dated November 27, 1945, shall remain in full force and effect.

3. This first supplemental order shall become effective thirty (30) days after the date hereof.
