OPINION

Applicant, Spyros Skliris, doing business as Skliris
Transit Lines, presently rendering a passenger stage service between
Hayward and Castro Valley and within the residential tract known as
San Lorenzo Village, seeks an extension of his existing authority to
transport passengers between a newly developed portion of San Lorenzo
Village, known as Washington Manor and Castro Valley.

A public hearing was held before Examiner Daly on October 4, 1951. An appearance in protest to the authority sought was made by Key System Transit Lines.

Applicant was authorized in Decision No. 44616, dated August 1, 1950, in Application No. 31015, to operate between Hayward and Castro Valley and within San Lorenzo Village. The proposed extension, a distance of approximately three miles, would cover a newly developed portion of San Lorenzo Village and connect with the Hayward and Castro Valley route via Lewelling Boulevard and Castro Valley Boulevard.

Applicant proposes to operate 30-minute schedules daily from 6:30 a.m. to 7 p.m. He proposes to charge a fare of 15 cents for adults and eight cents for children between the ages of five and 10 years.

According to applicant, he presently owns four busses. At the present time, he testified, he is using two busses on the Hayward-Castro Valley operation and one bus on the San Lorenzo Valley route. The latter route, according to applicant, is operated only three days a week--on Mondays, Wednesdays and Fridays--due to the poor patronage. The Hayward-Castro Valley route, he claimed, is now patronized by approximately 400 passengers a day. Applicant believes that the proposed extension would meet a need for those 9,000 new residents of Washington Manor, who are presently without convenient public transportation, in addition to improving his San Lorenzo Village route both from an operating and financial point of view.

Applicant failed to introduce any evidence of his financial ability, claiming that his accountent was presently out of the state and unavailable. However, he assured the Commission that an appropriate financial statement would be furnished the Commission upon his accountant's return.

One public witness was called in support of the application. The witness, a resident of Washington Manor, as well as the second vice-president of the Home-Owners Association, testified that the greatest need for public transportation was between Washington Manor and Oakland, particularly during the peak hours. He stated that there also existed a need for public transportation between San Lorenzo Village and Hayward. To avail themselves of public transportation to Oakland and Hayward, he testified, residents of Washington Manor are required to walk 11 blocks to the existing Key System route.

(b) Within sixty (60) days efter the effective date hereof, and on not less than five (5) days' notice to the Commission and the public, applicant shall establish the service herein authorized and comply with the provisions of General Order No. 79 and Part 19 of General Order No. 98 by filing, in triplicate, and concurrently making effective, appropriate tariffs and time schedules.

(c) Subject to the authority of this Commission to change or modify it by further order, applicant shall conduct the operations authorized in paragraph 1 of this order over the following route:

"Commencing at the intersection of Grant Avenue and Via Alamitos, thence along Grant Avenue, Lorenzo Avenue, West Avenue 152, Norton Street, Lewelling Boulevard, Dover Street, West Avenue 153, Farnsworth Street, Corvallis Street, Drake Avenue, Bethany Street, Post Avenue, Purdue Street, Zelma Street, West Avenue 150, Kesterson Street, Beatrice Street, Lorenzo Avenue, Lewelling Boulevard, East 14th Street, Mattox Road, Castro Valley Boulevard to its intersection with Stanton Avenue."

The effective date of this order shall be twenty (20) days
