Schedule No. 2

GENERAL FLAT RATES NONPERMANENT RESIDENTS

APPLICABILITY

Applicable to all water service rendered to nonpermanent residents on a flat rate as more fully specified below:

TERRITORY

In and in the vicinity of the town of Dutch Flat, Placer County, California.

RATES

Minimum Annual Charge, payable in advance, for which the customer is entitled to water service for a period of any number of consecutive months in the calendar year at the rates provided in Schedule No. 1 \$17.50

For any excess of service over and above the \$17.50 charge during the months of May to October, inclusive, or for single months of service thereafter, the rates provided in Schedule No. 1 will apply.

Schedule No. 4

GENERAL METER RATES NONPERMANENT RESIDENTS

APPLICABILITY

Applicable to all water service rendered to nonpermanent residents on a metered basis as more fully specified below. The application of this rate instead of the flat rate is optional on the part of the utility, or upon application of the customer.

TERRITORY

In and in the vicinity of the town of Dutch Flat, Placer County, California.

RATES

Minimum Annual Charge:

Payable in advance, for which the customer is entitled to water service for a period of any number of consecutive months in the calendar year at the General Moter Rate Schedule No. 3 \$16.00

For any excess of service over and above the \$16.00 charge during the months of May to October, inclusive, or for any single month of service thereafter, the rates provided in Schedule No. 3 will apply.

For the intermittent use of water on week ends and/or holidays for the six-month period from November through April on the premises of customers where payment of the Minimum Annual Charge of \$16.00 has been made during the six-month period from May through October, 6.00 inclusive, payable in advance or, if period is less than six months, \$1.00 per month. If more than 300 cubic feet is used the charge will be at the full regular rate as provided in meter schedule.
