FIRST SUPPLEMENTAL ORDER

The Commission having on November 20, 1951, issued its Decision No. 46449 in the above-entitled proceeding, wherein a schedule of rates was established for the water delivered in and in the vicinity of Huntington Beach, Orange County, and it appearing that the rate for the use of water in the 2,000 cubic-foot block was inadvertently shown as \$0.21 per 100 cubic feet, whereas it should have been shown as \$0.23 per 100 cubic feet, now, therefore, good cause appearing

IT IS HEREBY ORDERED that Schedule No. 1 of Exhibit A attached to the order in Decision No. 46449, issued November 6, 1951, be and it is modified to read as in Exhibit B attached hereto.

IT IS HEREBY FURTHER ORDERED that in all other respects said Decision No. 46449 shall remain in full force and effect.
