O P I N I O N

Decision No. 45899, dated June 29, 1951, in part, authorized 20th Century Delivery Service, Inc., applicant herein, to acquire from Goodman Delivery Service Inc., the latter's operating rights as an express corporation. By this application authority is sought to cancel Goodman Delivery Service Inc. Local Express Tariff Cal. P.U.C. No. 3.

A public hearing was held at Los Angeles, November 19, 1951. Oral and documentary evidence was adduced and the matter was submitted for decision.

The record shows and we find that applicant acquired the aforesaid Goodman express operating rights pursuant to the authority granted in Decision No. 45899; that of approximately 253 points named in the Goodman Delivery Service Inc. Local Express Tariff, Cal. P.U.C. No. 3, some 155 points were and are also served by applicant; that 20th Century Delivery Service, Inc. proposes to continue to serve said common points at the rates, upon the terms and conditions, and subject to the regulations as set forth in its own tariff now on file with this Commission; that for the years 1945 to 1950 inclusive, the express revenue and

express privileges paid, of Goodman Delivery Service Inc., were as follows:

That for the past several years Goodman Delivery Service Inc. has not been actively engaged in business as an express corporation; that the proposed cancellation of the said Goodman Delivery Service Inc. Local Express Tariff, Cal. P.U.C. No. 3 is not adverse to the public interest.

The application will be granted.

O R D E R

A public hearing having been held, the Commission being fully advised in the premises, and good cause appearing,

IT IS ORDERED:

(1) That 20th Century Delivery Service, Inc., a corporation, shall, within thirty (30) days after the effective date hereof, and upon not less than five (5) days' notice to the Commission and to the public, cancel the tariff applicable to the express operative rights which it acquired from Goodman Delivery Service Inc., pursuant to Decision No. 45899, dated June 29, 1951, which tariff is designated as Goodman Delivery Service Inc. Local Express Tariff Cal. P.U.C. No. 3.

(2) Upon the cancellation of said tariff as herein provided, the said express operating rights originally acquired by Louis M. Goodman, and referred to in Decision No. 29899, dated June 28, 1937, and Decision No. 45899 are hereby declared to have lapsed and to have become void.

The effective date of this order shall be twenty (20) days after the date hereof.
