## <u>O P I N I O N</u>

By this application Swenson's Livery, Inc., a corporation, requests authority to sell its passenger stage operations between Santa Monica, on the one hand, and the Hollywood Park and Santa Anita race tracks and the Los Angeles International Airport, on the other hand (Decisions Nos. 38222, 39540, 42346 and 45370) to Beverly Hills Garage, Inc., a corporation. The latter company now operates a race track passenger stage service from Westwood Village, Beverly Hills Hotel, and Culver City (Decisions Nos. 43862 and 44213).

The consideration for the operating rights is \$5,000.00, which includes goodwill and other city and county licenses, but no tangible property. The terms of payment are cash upon transfer after authorization.

The seller desires to retire from the race track transportation business.

The purchaser is experienced in the operation of bus service to and from race tracks, owns and maintains adequate equipment and facilities, and is financially responsible.

No material change is proposed in the existing schedules and fares.

Having considered the matter, this Commission finds that the proposed sale and transfer is not adverse to the public interest, and, therefore, the application will be granted. A public hearing is not necessary.

The action taken herein shall not be construed to be a finding of value of the property herein proposed to be transferred.

## ORDER

Application having been made, the Commission being fully advised in the premises and good cause appearing,

IT IS ORDERED:

(1) That Swenson's Livery, Inc., a corporation, be, and it hereby is, authorized to sell and transfer, on or before March 1, 1952, to Beverly Hills Garage, Inc., a corporation, and the latter is authorized to acquire and operate, the passenger stage operating rights described in the foregoing opinion.

(2) That applicants shall comply with the provisions of General Order No. 79 and Part 19 of General Order No. 98 by filing in triplicate and concurrently making effective appropriate tariffs and time tables within sixty (60) days from the effective date hereof on not less than one (1) day's notice to the Commission and the public.
