## OPINION AND ORDER

By Decision No. 45379, dated February 20, 1951, pursuant to Application No. 30519, 3rd Supplemental, the Commission renewed the license of Ernest E. Stubblefield to engage in the business of a motor transportation broker at Los Angeles. The license expired December 31, 1951.

Stubblefield filed Application No. 30519, 4th Supplemental, requesting renewal of his license at the same address and for authority to represent one additional carrier. The application was received at the offices of the Commission on January 2, 1952, two days subsequent to the expiration of the 1951 license. The application indicates that there has been no material change in the character of applicant's business since the grant of the original license. It will, therefore, be treated as a request for renewal of the original authority. Applicant is cautioned, however, to file future requests for renewal of his license at least thirty days prior to the expiration of the period for which the license is issued, so as to avoid possible lapse of authority resulting from failure to secure timely action on the application.

After full consideration of applicant's request it appears that the license should be granted and that authority should be granted to serve the additional carrier. A public hearing is not deemed necessary.

Therefore, good cause appearing,

IT IS ORDERED that the application of Ernest E. Stubblefield for a license to act as a motor transportation broker, as defined in Section 4803, Public Utilities Code, be and the same is granted, subject to the following conditions:

- 1. That said licensee shall keep his license certificate as a motor transportation broker posted at his authorized place of business so that it is readily available to public inspection at all times.
- 2. That said licensee shall do business as a motor transportation broker only at 228 Wholesale Terminal Building, 1304 East Seventh Street, Los Angeles 21, California, until otherwise authorized by the Commission, and for motor carriers hereinafter named, or for whom he may hereafter from time to time be permitted to do business by any subsequent order or orders of the Commission.

IT IS FURTHER ORDERED that the license of said applicant shall authorize him to sell, offer for sale, negotiate for, furnish or provide transportation of property over the public highways of this state, said transportation to be rendered only by the carriers whose names, addresses and permit numbers appear in Decision No. 45379, and in addition by the following carrier:

IT IS FURTHER ORDERED that the Secretary of the Public Utilities Commission is hereby authorized and directed to issue and deliver to said Ernest E. Stubblefield the license certificate of the authority hereby granted, said license certificate to be
