O P I N I O N

By Decision No. 43372, dated October 4, 1949, applicant was granted a temporary certificate of public convenience and necessity to operate a passenger stage service "in the City of Burbank and in the community of North Hollywood" over and along certain described routes. Said temporary authority has been extended to and including May 1, 1952 (Decisions Nos. 44805, 46056 and 46369).

By this application authority is sought to discontinue service along Alameda Avenue between Buena Vista Street and Olive Avenue, and to extend service along Buena Vista Street between Alameda Avenue and the entrance to St. Joseph's Hospital.

As justification for said proposal, applicant alleges that the line proposed to be rerouted was formerly operated by Burbank City Lines to St. Joseph's Hospital; that, due to public convenience and necessity, and by its inadvertence, applicant continued said operation to the hospital instead of the prescribed route along Alameda Avenue; that continuation of the present route to said hospital is in the public interest; that discontinuance of service as proposed will not materially inconvenience present patrons; that all of the service herein referred to is wholly within the

City of Burbank and that said city is not opposing the proposed change.

Having considered applicant's request, the Commission finds that public convenience and necessity require that the application be granted. A public hearing is not necessary.

O R D E R

Application having been made, the Commission being fully advised in the premises, and having found that public convenience and necessity so require,

IT IS ORDERED:

(1) That the third paragraph of subparagraph (c) of paragraph (4) of the Order in Decision No. 43372, on Application No. 30636, be and it hereby is amended to read as follows:

Commencing at the main entrance to St. Joseph's Hospital in the City of Burbank, thence along Buena Vista Street, Alameda Avenue, Lake Street, Verdugo Avenue, San Fernando Road, Burbank Boulevard, Victory Boulevard, Evergreen Street, Jeffries Avenue, Manning Street, Victory Boulevard to Burbank Boulevard, and return via same route to the point of beginning.

(2) That except as herein authorized and heretofore amended or supplemented, Decision No. 43372 shall remain in full force and effect.

The effective date of this order shall be twenty (20) days after the date hereof.
