OPINION AND ORDER AUTHORIZING DISCONTINUANCE OF FILING
OF SPECIAL REPORTS

In these supplemental applications California Water Service Company, ^{1/}a corporation, asks for authority to discontinue the filing of the special annual reports ordered in the Commission's Decisions Nos. 32905 and 33176, issued March 19, 1940, and June 4, 1940, respectively. In these decisions the Water Company was

authorized to enter into an agreement with Pacific Gas and Electric Company,^{2/}Tide Water Associated Oil Company^{3/}and Shell Oil Company, Incorporated,^{3/}providing for the sale and delivery of untreated water at a special rate through separate distribution facilities, for use in the steam plants owned and operated by Pacific and the Oil Companies at Avon and Martinez, in Contra Costa County, and the Water Company was ordered to file special annual reports showing the result of operation of this class of service.

On July 3, 1951, the Commission issued its Decision No. 45191, in Application No. 31421, authorizing the Water Company to file a rate schedule applicable to the delivery and sale of the untreated water covered by the above-mentioned agreement. This decision makes it unnecessary to file special reports for the contract service as the cost of supplying it was considered in establishing the rate.

The Commission having considered the request of Water Company and being of the opinion that the requested authority should be granted and that a public hearing is not necessary; therefore,

IT IS HEREBY ORDERED that California Water Service Company, a corporation, be and it is hereby authorized to discontinue filing the special annual reports heretofore required by
