Application of SAN DIEGO TRANSIT SYSTEM, a corporation, for a certificate of public convenience and necessity to operate bus service on Laurel Street, between Pacific Highway and Harbor Drive, all in the City of San Diego.

## $\underline{O P I N I O N}$

By this application authority is sought to supplement present service along Pacific Highway by extending said service along Laurel Street to the Ryan Aeronautical Company plant situated on Harbor Drive approximately three-quarters of a mile from the intersection of Laurel Street and Pacific Highway.

Said aeronautical company now operates a shuttle service along said route to meet the needs of some of its 4,000 employees. It has requested applicant to replace its private operation, and the latter is willing to do so provided authority is obtained.

It is alleged that additional costs of operation will be small, that present fares will apply, and that the service will be co-ordinated with present routes and schedules at shift change periods.

The application is not opposed.

Having considered the matter, we find that public convenience and necessity require that the application be granted. A public hearing is not necessary.

## <u>order</u>

Application having been made, and the Commission being fully advised in the premises and having found that public convenience and necessity so require,

IT IS ORDERED:

(1) That a certificate of public convenience and necessity be, and it hereby is, granted to San Diego Transit System, a corporation, authorizing the establishment and operation of a passenger stage service, as that term is defined in Section 226 of the Public Utilities Code, for the transportation of persons along Laurel Street between Pacific Highway and Harbor Drive, in the City of San Diego, as an enlargement and extension of, and to be consolidated with, its present operating rights.

(2) That in providing service pursuant to the certificate herein granted, there shall be compliance with the following service regulations:

- (a) Within thirty (30) days after the effective date hercof, applicant shall file a written acceptance of the certificate herein granted.
- (b) Within sixty (60) days after the effective date hereof, and upon not less than five (5) days' notice to the Commission and the public, applicant shall establish the service herein authorized and file in triplicate and concurrently make effective tariffs and time schedules satisfactory to the Commission.

 (c) Subject to the authority of this Commission to change or modify such at any time, San Diego Transit System shall conduct said passenger stage operations over and along the following-described route:

> Laurel Street between Pacific Highway and Harbor Drive.

Applicant is authorized to turn its motor vehicles at termini and intermediate points, in either direction, at intersections of streets or by operating around a block contiguous to such intersections, or in accordance with local traffic rules.
