ORDER REVOKING OPERATIVE RIGHT

It appearing that by Decision No. 40150, dated April 8, 1947, pursuant to Application No. 27817, as amended, Lloyd G. Thomson was authorized to establish and operate a service as a passenger stage corporation for the transportation of passengers and their baggage and certain express shipments between Mariposa and Merced and intermediate points; that by Decision No. 42698, dated April 12, 1949, pursuant to Application No. 29441, said Lloyd G. Thomson was authorized to establish and operate a service as a passenger stage corporation for the transportation of passengers and their baggage between Mariposa, Yosemite Park Line and all intermediate points; that no evidence of adequate protection against liability imposed by law for the payment of damages for personal injury or property damage has been filed with the Commission by said Lloyd G. Thomson, as required by General Order No. 101; and that the passenger stage service in question has been

discontinued for a substantial period of time without any authorization to suspend or discontinue such operations; therefore, it is found that Lloyd G. Thomson is no longer conducting and has abandoned said passenger stage operation.

IT IS ORDERED that the certificates issued to Lloyd G. Thomson by Decision No. 40150 in Application No. 27817 and by Decision No. 42698 in Application No. 29441 are hereby revoked, and all effective tariffs and timetables on file in the name of Lloyd G. Thomson are hereby canceled.

The Secretary is directed to cause a certified copy of this order to be served upon Lloyd G. Thomson.

The effective date of this order shall be the twentieth (20th) day after service of a copy hereof upon Lloyd G. Thomson, unless said Lloyd G. Thomson before such effective date shall have filed with this Commission a written response to this order, denying the facts set forth herein and requesting a public hearing thereon, in which event the effective date of this order will thereby be stayed until hearing is had and further order issued.
