OPINION.

Joe Mangini Draying Co., Inc., a California corporation has been operating as a highway common carrier pursuant to authority of this Commission. This corporation now proposes to transfer all its assets including its operating rights and equipment to Isabella Mangini, Abbie Frew McKown and Irene Malcolm its sole stockholders who will carry on its operations as a partnership doing business under the name of Joe Mangini Draying Co. As the reason for dissolving the corporation it is stated that it will effect operating economies. No money will be paid for such transfer. The Commission has considered this matter and is of the opinion that a public hearing thereon is not necessary. This transfer and the operation thereafter of the operative rights and equipment are found not to be adverse to the public interest. Consequently, the transfer of operative property and rights is approved and the partners will be authorized to continue the business formerly carried on by applicant corporation under the firm name of Joe Mangini Draying Co.

ORDER

Application having been made to the Public Utilities

Commission for an order authorizing the transfer of operative rights

and properties, and the Commission having considered the matter and being of the opinion that a public hearing is not necessary and that the application should be granted as herein provided,

IT IS ORDERED:

- (1) That applicant Joe Mangini Draying Co., Inc., after the effective date hereof may transfer its operative rights and property to applicants Isabella Mangini, Abbie Frew McKown and Irene Malcolm, copartners doing business as Joe Mangini Draying Co., who may thereafter exercise such operative rights.
- (2) That the action taken herein shall not be construed to be a finding of the value of the property herein authorized to be transferred
- (3) That applicants Isabella Mangini, Abbie Frew McKown and Irene Malcolm doing business as Joe Mangini Draying Co. shall file in triplicate, and concurrently make effective, appropriate tariffs and time schedules on not less than five (5) days' notice to the Commission and to the public.

The effective date of this order shall be twenty (20) days after the date hereof.
