O P I N I O N

Applicant, Pacific Greyhound Lines, presently rendering service as a passenger stage corporation for the transportation of passengers, baggage and express throughout the state seeks authority to operate between the East Bay Distribution Structure, Oakland, and East 14th Street, Hayward.

Applicant is presently rendering service over related routes by virtue of authority granted in various Commission decisions. The proposed route would not result in any change of present rates nor require the use of additional equipment.

In justification of the authority sought, applicant alleges that a new freeway has been constructed between the junction of Sixth and Oak Streets, Oakland, and the junction of said freeway with Washington Avenue, in the vicinity of San Lorenzo; that such freeway has now been opened for public use; that applicant's present route between Oakland and Hayward via U. S. Highway and East 14th Street is heavily traveled; that it was to relieve such congestion for through traffic that said freeway was constructed and that the use of said freeway would reduce the required traveling time by at least 50 per cent.

After full consideration, the Commission is of the opinion that the application should be granted. A public hearing does not appear to be necessary.

O R D E R

An application having been filed, the Commission being fully informed in the premises and finding that public convenience and necessity so require,

IT IS ORDERED:

(1) That as an extension and enlargement of its existing rights a certificate of public convenience and necessity is hereby granted to Pacific Greyhound Lines authorizing the establishment and operation of service as a passenger stage corporation, as defined in Section 226 of the Public Utilities Code, for the transportation of passengers, baggage and shipments of express not exceeding 100 pounds each in weight in passenger carrying vehicles only, between the East Bay Distribution Structure, Oakland, and East 14th Street, Hayward.

(2) That in providing service pursuant to the certificate herein granted, applicant shall comply with the following service regulations:

- (a) Applicant shall file a written acceptance of the certificate herein granted within a period of not to exceed thirty (30) days after the effective date hereof.
- (b) Within sixty (60) days after the effective date hereof and on not less than five (5) days' notice to the Commission and the public, applicant shall establish the service herein authorized and comply with the provisions of General Orders Nos. 79, 80 and Part 19 of General Order No. 98, by filing in triplicate, and concurrently making effective, appropriate tariffs and time schedules.
- (c) Subject to the authority of this Commission to change or modify it by further order, applicant shall conduct operations over the following routes:
 - (1) Westbound: From the East Bay Distribution Structure over access highway to Cypress Street, thence over Cypress Street to Seventh Street to junction Seventh Street and Oak Street.

- (2) Eastbound: From the junction of Seventh Street and Oak Street, over Oak Street to Eighth Street to Cypress Street to access highway to East Bay Distribution Structure.
- (3) From the junction of Oak Street and East 14th Street, over Oak Street to its junction with Sixth Street.
- (4) From the junction of Oak Street and Sixth Street, over East Shore Freeway to junction Washington Avenue, thence over Washington Avenue to Lewelling Boulevard to junction East 14th Street, to be operated as an alternate route only and subject to the restriction that no passenger, baggage or express may be picked up or discharged along said route.

The effective date of this order shall be twenty (20) days after the date hereof.
