SUPPLEMENTAL OPINION AND ORDER

Decision No. 47567, entered today in this proceeding, makes certain revisions in the minimum rates, rules and regulations which have been established heretofore for the transportation of property for motion picture studios and extends the application of the rates to transportation for television studios.

The rates, rules and regulations partly supersede provisions of City Carriers' Tariff No. 7 - Highway Carriers' Tariff No. 9 (Appendix "A" of Decision No. 35055, as amended, in Cases Nos. 4246 and 4434). That tariff should be amended accordingly.

Therefore, good cause appearing,

IT IS HEREBY ORDERED that Decision No. 35055, as amended, in Cases Nos. 4246 and 4434, be and it is hereby further amended by incorporating in City Carriers' Tariff No. 7 - Highway Carriers' Tariff No. 9, to become effective September 10, 1952, the revised

In all other respects Decision No. 35055, as amended, shall remain in full force and effect.
