In the Matter of the Application of Clyde C. Flinn for a certificate of public convenience and necessity to operate a passenger service between the Village of Crestline in San Bernardino Mountains and Lake Gregory. Said certificate of public convenience and necessity to be seasonal and on an annual basis.

<u>o p i n i o n</u>

By Decision No. 45976, applicant was authorized to operate a passenger stage service between Lake Gregory on the one hand, and on the other hand a point on Crest Forest Drive approximately three city blocks south of Fern Drive in the Village of Crestline, all in Son Bernardino County, serving all intermediate points for the period commencing June 15 and continuing through October 1 of each year. Applicant now requests permission to extend his service from Crestline Village and Lake Gregory to a resort known as the Valley of Enchantment, situated approximately one and one-half miles from the Crestline community. Six round trips per day are proposed on a seasonal basis between June 15 and October 1. The fares will be 10 cents one way, with free transportation for children under five years of age when accompanied by an adult.

The application is not opposed by Jack A. Roesch, the only other passenger stage operator in that locality.

Having fully considered the matter, the Commission finds that public convenience and necessity require the establishment and operation of a passenger stage service as proposed. The application will be granted. A public hearing is not necessary.

## $O \underline{R} \underline{D} \underline{E} \underline{R}$

Application having been made, the Commission being fully advised in the premises and having found that public convenience and necessity so require,

IT IS ORDERED:

(1) That a certificate of public convenience and necessity be and the same hereby is granted to Clyde C. Flinn, authorizing the establishment and operation of a seasonal service, commencing on June 15 and continuing to October 1 of each year, as a passenger stage corporation, as defined in Section 226 of the Public Utilities Code, for the transportation of passengers between the Village of Crestline and Lake Gregory, on the one hand, and the Valley of Enchantment, on the other hand, and intermediate points.

(2) That, in providing service pursuant to the certificate herein granted, applicant shall comply with and observe the following service regulations:

> (a) Within thirty (30) days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted.

- (b) Applicant shall comply with all safety regulations of the Commission, especial reference being made to Part 9 of General Order No. 98 forbidding the use of trailers attached to passenger stage vehicles.
- (c) Subject to the authority of this Commission to change or modify such at any time by further order, applicant shall conduct operations, pursuant to the certificate herein granted, over and along the most appropriate highway or road between the points herein authorized to be served.

The effective date of this order shall be twenty (20)
