At such time, the Commission will set this proceeding for further hearing and will consider said report and any other pertinent evidence presented at such hearing.

THEREFORE, IT IS HEREBY ORDERED that The Pacific Telephone and Telegraph Company be and become a party defendant to this proceeding and that plaintiffs furnish said company with a copy of the complaint, herein, within ten (10) days after the effective date of this order and said defendant shall have ten (10) days within which to answer said complaint if it desires to make answer thereto.

IT IS FURTHER ORDERED that Associated Telephone Company, Ltd. and The Pacific Telephone and Telegraph Company make a comprehensive survey, study and report concerning the matters involved in the issues and the relief prayed for herein and within ninety (90) days after the effective date of this order file the same with the Commission and furnish copies thereof to the plaintiffs, herein, and the staff of the Commission.
