SUPPLEMENTAL OPINION AND ORDER

Upon the petition of the Truck Owners Association of California the Commission established an interim 9 percent increase in the state-wide minimum rates for the transportation of fresh fruits and vegetables pending the establishment of permanent rates (Decision No. 47436 of July 8, 1952). The increase expires November 20, 1952, unless sooner canceled, changed or extended.

Further hearings were held at San Francisco on September 3 and 4, 1952. At these hearings further studies were submitted. The matter was submitted September 4, 1952. However, a final determination of the matter cannot be made in time to become effective prior to the expiration of the temporary increases. In view of these developments and in view of the fact that the 9 percent surcharge was established to expire with November 20, 1952, unless sooner canceled, changed or extended, petitioner requested that the application of that surcharge be extended for such period as the Commission might deem advisable.

In the circumstances, the expiration date of the temporary surcharge will be extended to December 31, 1952, subject to earlier cancellation, change or further extension as the need therefor may be made to appear.

Therefore, good cause appearing,

IT IS HEREBY CRDERED that the first ordering paragraph of Decision No. 47436 of July 8, 1952, in this proceeding, be and it is hereby amended by substituting "to become effective November 20, 1952, Supplement No. 6 cancels Supplement No. 5, attached hereto and by this reference made a part hereof" for "to become effective July 23, 1952, Supplement No. 5 cancels Supplement No. 4, attached hereto and by this reference made a part hereof"; that the second ordering paragraph of said Decision No. 47436 be and it is hereby amended by substituting "on not less than three (3) days' notice" for "not earlier than July 23, 1952, and on not less than one (1) day's notice"; and that in all other respects said Decision No.47436 shall remain in full force and effect.

This order shall become effective twenty (20) days after the date hereof.
