ORDER REVOKING OPERATIVE RIGHTS

It appearing by Commission Decisions Nos. 40783, 41352  
and 42452, issued in the above applications that R. P. Geddes, Jr.,  
F. C. Horn and H. A. Pike, copartners doing business as Palomar  
Mountain Stages, were authorized to operate an "on-call" passenger

stage service for the transportation of persons and their baggage and express between Oceanside and Mount Palomar via Carlsbad, Vista, Bonsall, Pala, and Rincon and also over an alternative route via San Luis Rey and to provide regular transportation for school children between Oceanside and the San Luis Rey Mission School, situated on the alternative route; that no evidence of adequate protection against liability imposed by law for the payment of damages for personal injury or property damage has been filed with the Commission by said copartners, as required by General Order No. 101; that said copartners are desirous of having said operative rights revoked; and that the passenger stage service in question has been discontinued for a substantial period of time without any authorization to suspend or discontinue such operations; therefore, it is found that said copartners are no longer conducting and have abandoned said passenger stage operations.

IT IS ORDERED, that the certificates transferred and issued to R. P. Geddes, Jr., F. C. Horn and H. A. Pike, copartners doing business as Palomar Mountain Stages, by Decisions Nos. 40783, 41352, and 42452 in the above-entitled proceedings are hereby revoked and all effective tariffs and timetables on file in the names of R. P. Geddes, Jr., F. C. Horn and H. A. Pike, copartners doing business as Palomar Mountain Stages are hereby canceled.

The Secretary is hereby directed to cause certified copies of this order to be served upon R. P. Geddes, Jr., F. C. Horn and H. A. Pike, copartners doing business as Palomar Mountain Stages.

The effective date of this order shall be the twentieth (20th) day after service of a copy hereof upon R. P. Geddes, Jr., F. C. Horn and H. A. Pike, or any one of them, unless said R. P. Geddes, Jr., F. C. Horn and H. A. Pike, or any of them, before such

effective date shall have filed with this Commission a written response to this order, denying the facts set forth herein and requesting a public hearing thereon, in which event the effective date of this order will thereby be stayed until hearing is held and further order issued.
