O P I N I O N

In this application Pacific Greyhound Lines requests authority to establish a partial rerouting of its passenger stage operations between Chico and Orland in the Hamilton City-Mills Orchard area. The portion of the route involved is approximately three miles in length. As justification for the request, it is stated that the segment for which the proposed new route would be substituted is, in addition to its poor road conditions, extra hazardous because of the existence of at least six crossroad accesses thereto which are constantly used by trucks moving to and from Mills Orchard. Because of existing hazards the road has been posted for a maximum speed of 35 miles an hour. It is further stated that applicant has been informed that the owners of Mills Orchard will construct a passenger waiting shed at the intersection of California Highway 32 and the county highway presently used by applicant. Applicant plans to relocate the tariff point of Mills Orchard to a point less than one mile north of its present location, which will not be more distant from the sources of passenger traffic than the present location of that tariff point.

After full consideration we find that public convenience and necessity require the rerouting sought by applicant, which will be granted. No public hearing is necessary.

On November 3, 1952, the Commission issued to applicant a new certificate which superseded all of its operating rights existing at that time. (Decision No. 47907, Application No. 31883.) This is the first request for a modification of the routes which are described in Appendix A in said Decision No. 47907. The authority sought will be issued by an appropriate amendment to said Appendix A and is subject to all of the provisions and the service regulations set forth in said Decision No. 47907.

O R D E R

An application therefor having been filed and the Commission having found that public convenience and necessity so require,

IT IS ORDERED that Appendix A of Decision No. 47907 is hereby amended by incorporating therein First Revised Page 10 attached hereto and by reference made a part hereof. The authority herein granted is consolidated with and made a part of the operative rights created by Decision No. 47907.

In all other respects said Decision No. 47907 shall remain in full force and effect.

This order shall become effective twenty (20) days after the date hereof.

ROUTE GROUP 2

2.01 - Between Red Bluff and Roseville:

From Red Bluff, over U. S. Highway 99E to Roseville.

* 2.02 - Between Chico and Orland:

From Chico, over California Highway 32 to junction unnumbered highway near Hamilton City, thence over unnumbered highway to junction Canal Road, thence over Canal Road to junction California Highway 32, thence over California Highway 32 to Orland.

2.03 - Between Savona and Oroville:

From Savona, over unnumbered highway to Oroville.

2.04 - Between Durham and Durham Junction:

From Durham, over unnumbered highway to Durham Junction, to be operated as an alternate route.

2.05 - Between the Nevada-California State Line east of Purdy, and Oroville:

From the point where U. S. Highway 395 intersects the Nevada-California State Line, over U. S. Highway 395 to junction California Highway 24 (Hallelujah Junction), thence over California Highway 24 to Oroville.

2.06 - Between Sloat and Sloat Junction:

From Sloat, over unnumbered highway to junction California Highway 24 (Sloat Junction).

2.07 - Between Oroville and Oroville Wye:

From Oroville, over California Highway 24 to junction unnumbered highway, thence over unnumbered highway to junction U. S. Highway 99E (Oroville Wye).

2.08 - Between Biggs Junction and Gridley Junction:

From Biggs Junction, over unnumbered highway via Biggs and Gridley to junction U. S. Highway 99E (Gridley Junction).
