## <u>o p i n i o n</u>

Applicants Arthur V. Harvey and William D. Bourne, doing business as West Orange Transit Company, presently rendering a passenger stage service between Long Beach and Stanton request authority to change a portion of their route in the City of Long Beach.

The present operation was authorized by Decision No. 45460 dated March 13, 1951, in Application No. 32064, and was subsequently amended by Decision No. 45978 dated July 24, 1951, in Application No. 32424.

The existing route commences at the intersection of American Avenue and East First Street, thence continues along East First Street for a mile to Alamitos Avenue, thence along Alamitos Avenue for another mile to East Anaheim Street. The proposed route would also commence at the intersection of American Avenue and East First Street with a provision for turn around privileges, thence would continue along American Avenue to its intersection with East Anaheim Street, along East Anaheim Street following the remainder of the route as presently described.

As justification for the authority sought applicants allege that the proposed rerouting would provide a more convenient access for passengers to the downtown area of Long Beach and thus meets with the approval of the City of Long Beach.

After full consideration of the matter the Commission is of

the opinion that the application should be granted. A public bearing does not appear to be necessary.

## ORDER

Application as above-entitled having been filed, the Commission being fully advised in the premises, and hereby finding that public convenience and necessity so require,

IT IS ORDERED:

(1) That the route description in paragraph (2),
subparagraph (c) of the Order in Decision No. 45460 dated March 13,
1951, in Application No. 32064, and as amended by Decision No.
45978 dated July 24, 1951, in Application No. 32424 is hereby amended
to read as follows:

"Commencing at the intersection of American Avenus and East First Street (with turn around privileges along American Avenue, Ocean Boulevard, Alley between American Avenue and Locust Avenue, East First Street to American Avenue) thence along American Avenue to East Anaheim Street, Bellflower Boulevard, Spring Street, Los Alamitos Boulevard, Farquhar Street, Lexington Avenue, Howard Street, Los Alamitos Boulevard, Lincoln Avenue (Carson Street), Stanton Avenue (Huntington Beach Boulevard), to its intersection with Katella Avenue in the Community of Stanton in Orange County.

Also along Grand Avenue between Lincoln Avenue and Stanton Avenue."

(2) That in all other rospects Decision No. 45460 shall remain in full force and effect.

The offective date of this order shall be twenty (20) days after the date hereof.
