In the matter of the application of PACIFIC GAS AND ELECTRIC COMPANY, a corporation, for an order of the Public Utilities Commission of the State of California granting and conferring upon applicant all necessary permission and authority to carry out the terms and conditions of a written agreement with Marian Chichizola, as Administratrix of the Estate of Mazel M. Chichizola, Deceased, operating under the name and style of JACKSON GATE WATER WORKS, dated February 13, 1953 (Exhibit "A" hereof). (Water)

OPINION AND ORDER

Pacific Gas and Electric Company, a corporation, by the above-entitled application filed February 25, 1953, requests the Commission for authority to carry out the terms of an agreement, dated February 13, 1953, with Marian Chichizola, as administratrix of the estate of Hazel M. Chichizola, deceased, operating under the name and style of Jackson Cate Water Works. This agreement pertains to the sale of untreated water by Pacific Gas and Electric Company to the Jackson Gate Water Works for resale after treatment to its consumers through its facilities in and near the community of Jackson Gate, Amador County.

A prior agreement between these two parties, dated January 31, 1948, for the sale and purchase of water was filed with the Commission. This agreement was subsequently modified in accordance with Decision No. 41799 (Application No. 29097), dated July 7, 1948, by an amendatory agreement dated July 30, 1948. The agreement herein requested to be approved is similar to this earlier agreement as modified except as to the rates therein.

The present agreement provides, among other things, that deliveries of water are to be made at the point where the Jackson Gate Water Works: conduit connects with Pacific Gas and Electric Company's header box at the outlet end of its Oneida Pipeline on its Jackson Canal approximately 6,000 feet downstream from its Tanner Reservoir. The quantity of water so delivered is to be measured at said point of delivery, and such water is to be sold and delivered to, and paid for by, Jackson Gate Water Works at the rates, charges and conditions on file and applicable thereto as set forth in Schedule No. R-1, "Resalc Service - Untreated Water," for the Jackson Water System of the Pacific Gas and Electric Company authorized by Decision No. 46990 (Application No. 32722), dated April 14, 1952. This resale schedule is available only upon contract as specified under the special conditions therein.

The agreement is for an initial period of one year, commencing February 5, 1953, and thereafter until terminated by either party upon thirty days: written notice.

The Commission having considered the request of the company and being of the opinion that the application should be granted and that a public hearing is not necessary, therefore,

IT IS HTREBY ORDERED that Pacific Gas and Electric Company, a corporation, be and it is authorized to carry out the terms of the agreement with Marian Chichizola, as administratrix of the estate of Hazel M. Chichizola, deceased, operating under the name and style of Jackson Gate Water Works, dated February 13, 1953, as set forth in Exhibit A attached to the application, which exhibit is made a part of this order by reference, subject to the following conditions:

1. Applicant shall file with the Commission within thirty days after the effective date of this order, two

certified copies of the agreement as executed, together with a statement of the date on which the agreement is deemed to have become effective.

2. Applicant shall notify this Commission of the date of termination of said agreement within thirty days after said date of termination.

The effective date of this order shall be twenty days after the date hercof.
