SUPPLEMENTAL OPINION AND ORDER

Pursuant to a petition of the Draymen's Association of San Francisco interim rates have heretofore been established for drayage within San Francisco. The adjustment was made as a temporary measure to enable the carriers to meet operating costs pending the completion of studies by the Commission and by the carriers. These studies have not yet been completed. The interim increase is scheduled to expire with May 14, 1953.

By petition filed May 1, 1953, the Draymen's Association seeks a six-month extension of the interim increase. In the circumstances, the expiration date of the interim increase will be extended to expire with November 14, 1953, subject to earlier cancellation, change or further extension as the need therefor may be made to appear. A public hearing is not necessary. The order will be made effective May 15, 1953, to avoid lapse of the increase.

Therefore, good cause appearing,

IT IS HEREBY ORDERED that City Carriers' Tariff No. 1-A (Appendix "A" of Decision No. 41363 as amended) be and it is hereby

further amended by incorporating therein Supplement No. 6 cancels Supplement No. 5, attached hereto and by this reference made a part hereof.

The effective date of this order shall be May 15, 1953.

(1) APPLICATION OF SURCHARGE

(a) Except as provided in paragraph (b) below, compute the amount of charges in accordance with the rates, rules and regulations of the tariff. Increase the amount so computed by sixteen (16) percent, except as to rates and charges provided in Item No. 570 series. Increase the amount computed under Item No. 570 series by four (4) percent. Fractions will be disposed of as provided in paragraph (c) below.

(b) The provisions of paragraph (a) will not apply to rates and charges computed in accordance with Items Nos. 220, 222, 425 and 580 series.

(c) Fractions of less than one-half cent shall be dropped; fractions of one-half cent or greater shall be increased to one cent.

*(1) Expires with November 14, 1953, unless sooner canceled, changed or extended.
