SUPPLEMENTAL OPINION AND ORDER

In Decision No. 48786 entered today in Cases Nos. 5432 and 5441, the Commission established reduced ratings and rates for the transportation of canned egg yolk under the provisions of Highway Carriers' Tariff No. 2 and of the East Bay drayage tariff, and found that the necessary amendment of the drayage tariff should be made by separate order.

Therefore, good cause appearing,

IT IS HEREBY ORDERED that City Carriers' Tariff No. 2-A - Highway Carriers' Tariff No. 1-A (Appendix "A" to Decision No. 41362, as amended) be and it is hereby further amended by incorporating therein, to become effective August 1, 1953, the revised pages attached hereto and by this reference made a part hereof, which pages are numbered as follows:

Third Revised Page 4 Cancels Second Revised Page 4.

Third Revised Page 21 Cancels Second Revised Page 21.

IT IS HEREBY FURTHER ORDERED that tariff publications of common carrier respondents filed pursuant to this order may be made effective not earlier than August 1, 1953, and on not less than five days' notice to the Commission and to the public.

In all other respects, the aforesaid Decision No. 41362, as amended, shall remain in full force and effect.

This order shall become effective twenty days after the date hereof.
