O P I N I O N

Applicant Sacramento City Lines, presently rendering a passenger stage service in the City of Sacramento and immediate vicinity seeks authority to reroute one of its existing routes. According to applicant no additional equipment will be necessary to provide service as a result of the proposed extension.

The eastern terminus of Route No. 8 presently loops around several blocks outside the grounds of the Sacramento County Hospital and the proposed extension would eliminate the loop by entering the grounds of the Sacramento County Hospital making a turn and operating via the same streets in the return direction. As justification for the authority sought, it is alleged that the new route would facilitate the transportation of many patients going to the hospital and would alleviate the necessity of crossing a dangerous intersection. It would also accommodate many persons going to the Sacramento Labor Temple and to the new administration office of the State Fair Grounds. Attached to the application are letters written by the medical director of the Sacramento County Hospital, a traffic engineer for the City of Sacramento and representatives of the Building Trades Council which support the extension as proposed.

After full consideration the Commission is of the opinion and so finds that public convenience and necessity require

the granting of the authority sought. No public hearing appears to be necessary.

O R D E R

Application having been filed, the Commission informed in the premises and it having been found that public convenience and necessity so require,

IT IS ORDERED:

(1) That Route Description 8 as described in Decision No. 39438, dated September 24, 1946, in Applications Nos. 27492 and 27632 and as subsequently amended by Decisions Nos. 47176 and 47398 is hereby further amended to read as follows:

"Route No. 8

- "(a) Beginning at the intersection of Seavey Circle and 5th Street, thence along 5th Street, Sutter Way, Muir Way, Broadway, 3rd Street, K Street to the intersection of 5th Street.
- "(b) Beginning at the intersection of Broadway and 5th Street, thence along 5th Street, K Street, 9th Street, O Street, 14th Street, P Street, to its intersection with 15th Street.
- "(c) Beginning at the intersection of 17th Street and C Street, thence along C Street, 18th Street, D Street, 17th Street, C Street, 15th Street, P Street, Stockton Blvd., 34th Street, 2nd Avenue, Stockton Blvd., thence on the Sacramento County Hospital grounds to the main entrance of the hospital, thence leave the hospital grounds at Colonial Way and Stockton Blvd., thence along Stockton Blvd. to the intersection of X Street.
- "(d) Beginning at the intersection of 9th Street and K Street, thence along K Street, 10th Street to the intersection of O Street.
- "(e) Beginning at the intersection of P Street and 14th Street, thence along 14th Street, Q Street, 30th Street to the intersection of P Street.

The effective date of this order shall be twenty days after the date hereof.
