O P I N I O N

By this application authority is sought to extend the applicant's Route "G" bus line 2.6 miles from its present terminus at Imperial Avenue and 69th Street to the intersection of Cardiff Street and Sweetwater Avenue. <sup>(1)</sup> The entire route, including the proposed extension, is in the City of San Diego.

Applicant alleges that a new residential development known as Lomita Village consisting of 980 units is under construction near the end of the proposed extension. This village is a rental project and the proposed extension will provide the tenants with a needed transportation service for work, shopping and schools.

The application alleges that the proposed service is within applicant's service area and is not competitive with any other common carrier; that applicant proposes to incorporate

the extension into its established zone system of fares as shown in Local and Joint Passenger Tariff No. 2, Cal. P.U.C. No. 3, with all of the extension being in Zone 4; that the schedule proposed is that now operated on Route "G" consisting of 40 round trips, Monday through Friday, 46 trips on Saturday, and 33 trips on Sundays and holidays; and that the proposed extension will require an additional bus which will come from applicant's equipment pool.

A copy of the application was served on the City of San Diego on July 6, 1953. The City has approved the applicant's proposal.

Upon the allegations of the verified application, the Commission finds that public convenience and necessity require that the application be granted. A public hearing is not necessary.

O R D E R

Application having been made therefor, the Commission being fully advised in the premises and having found that public convenience and necessity so require,

IT IS ORDERED:

A

(1) That a certificate of public convenience and necessity be, and it hereby is, granted to San Diego Transit System, a corporation, authorizing the establishment and operation of a service as a passenger stage corporation, as that term is defined in Section 226 of the Public Utilities Code, for the transportation of persons between the intersection

of Imperial Avenue and 69th Street, on the one hand, and the intersection of Cardiff Street and Sweetwater Avenue, and intermediate points, all in the City of San Diego, on the other hand, as an extension of and to be consolidated with applicant's existing rights.

(2) That in providing service pursuant to the certificate herein granted, there shall be compliance with the following service regulations:

- (a) Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted.
- (b) Within sixty days after the effective date hereof, and upon not less than five days' notice to the Commission and the public, applicant shall establish the service herein authorized and file in triplicate, and concurrently make effective, tariffs and time schedules satisfactory to the Commission.
- (c) Subject to the authority of this Commission to change or modify such at any time, San Diego Transit System shall conduct said passenger stage operation over and along the following described route:

Beginning at the intersection of 69th Street and Imperial Avenue, thence over Lisbon Street, Jamacha Road, and Cardiff Street to its intersection with Sweetwater Avenue.

Applicant is authorized to turn its motor vehicles at termini and intermediate points, in either direction, at intersections of streets or by operating around a block contiguous to such intersections, or in accordance with local traffic rules.

IT IS FURTHER ORDERED:

B

That the route description of applicant's Route "G" bus line as set forth in Decision No. 45374, dated February 20, 1951, on Application No. 32077, is amended to read as follows, including the service authorized by paragraph A(2)(c) of the order herein:

Beginning at the intersection of Fifth Avenue and Market Street; thence along Market Street, Fourth Avenue, E Street, Fifth Avenue, Market Street, 32nd Street, Imperial Avenue, Lisbon Street, Jamacha Road, and Cardiff Street to Sweetwater Avenue.

The effective date of this order shall be twenty days after the date hereof.
