

<u>O P I N I O N</u>

Pursuant to authority from this Commission granted by Decision No. 47474, dated July 15, 1952, on Application No. 33379, Glendale City Lines, Inc., renders a passenger stage cervice for the transportation of children to and from schools in Los Angeles and Glendale when schools are in session. By the application herein it requests authority to discontinue school bus cervice in the City of Los Angeles via Blake Avenue between Riverdale and Dallas Streets, via Riverside Drive between Riverdale and Dallas Streets, via Birkdale Street between Blake Avenue and Riverside Drive, and via Riverdale between Riverdale Drive and Blake Avenue.

As grounds for the changes applicant alloges that it has received a letter<sup>2</sup> from the principal of the Washington Irving Junior High School requesting the proposed discontinuance. This school is located near the intersection of Estara Avenue

and Fletcher Drive (X on Exhibit "A"). From the principal's letter (Exhibit "B") it appears that the route on which service is to be discontinued south of Dallas Street is in the Nightingale School District and the principal of the Washington Irving Junior High School does not desire that children from the Nightingale district be brought to the Washington Irving Junior High School.

No new routes are proposed to be used.

Upon the allegations of the verified application we find that the proposal is not opposed to the public interest. It will be granted. A public hearing is not necessary.

## $\underline{O} \underline{R} \underline{D} \underline{E} \underline{R}$

Application as above entitled having been filed, the Commission being fully advised in the premises and having found that the application is not opposed to the public interest, IT IS ORDERED:

(1) That the route description of applicant's school children's bus services set forth in ordering paragraph (2)(c) of the order of Decision No. 47474, dated July 15, 1952, on Application No. 33379, is amended to read as follows:

Verdugo Road from Town Street to San Gabriel Street, along San Gabriel Street from Verdugo Road to Canada Boulevard from Canada Boulevard to Country Club Drive, along Country Club Drive to Hermosita Drive, along Hermosita Drive to Opechee Way, along Opechee Way to Bonita Drive, along Bonita Drive to Wabasso Way, along Wabasso Way to Verdugo Road, also along Canada Boulevard from Towne Street to Santa Maria Avonue and along Clorietta Avenue from Canada Boulevard to Verdugo Road. On Don Jose Drive between Ethel Street and Mountain Street, along Rossmoyne Avenue between Mountain Street and Dryden Street,

along Everett Street between Dryden Street and Mountain Street, along Dryden Street between Everett Street and Rossmoyne Avenue, along Mountain Street between Everett Street and Rossmoyne Avenue, and along Ethel Street between Glenoaks Boulevard and Don Jose Drive, along Glenoaks Boulevard to Verdugo Road, also along Verdugo Road between Lexington Drive and Mountain Street. Along Verdugo Road between Broadway and Chevy Chase Drive and also along Chevy Chase Drive between Broadway and Verdugo Road. Also along Verdugo Road between Broadway and Colorado Street. Also along Verdugo Road from Garfield Avenue, thence southerly to Fletcher Drive, along Fletcher Drive to Rowena Avenue, along Rowena Avenue to Hyperion Avenue, along Hyperion Avenue between Rowens Avenue and Tracy Street, along Tracy Street between St. George Street and Hyperion Avenue, along St. George Street between Tracy Street and Griffith Park Boulevard, along Monon Street between St. George Street and John Marshall School. Also along Riversido Drive from Fletcher to Dallas, along Blake Avenue between Dallas and Benedict, along Dallas Street between Blake Avenue and Riverside Drive, along Blimp Street between Blake Avenue and Riverside Drive, along Benedict between Blake Avenue and Riverside Drive, along Ripple Street between Knox and Benedict, along Knox Avenue between Ripple Street and Riverside Drive. Also along Gracia Street between Glenhurst Avenue and Atwater Avenue, along Glendale Boulevard between San Fernando Road and Rowena Avenue. Also along Glenhurst Avonue between Glendale Boulevard and Gracia Street. Also along Brand Boulevard between San Fernando Road and Los Feliz. Along Los Feliz between Brand Boulevard and Glendale Avenue, along Glendale Avenue between Los Feliz and Broadway. Also along Brunswick Avenue between Los Feliz Boulevard and Goodwin Avenue. Also along Perlita between Rigali Avenue and Los Feliz Boulevard. Also along Rigali Avenue between Brunswick Avenue and Perlita. Along Goodwin Avenue between Brunswick Street and Alger Street, slong San Fernando Road West between Goodwin Avenue and Colorado Street. Also along San Fernando Road between Colorado Street and Pacific Avenue. A Along Colorado Street between San Fernando Road and Brand Boulevard. Also along San Fermando Road between Los Feliz Boulevard and Fletcher.
