## FIRST SUPPLEMENTAL ORDER

The Department of Public Works, Division of Highways, of the State of California, applicant, proposes as an integral part of the State highway system to improve and relocate State Highway Route No. 11 (U.S. No. 50) in the City of Placerville, El Dorado County, and in connection therewith, proposes construction of one crossing at separated grades, one pedestrian overcrossing, three new grade crossings, alteration of six existing grade crossings and elimination of one impaired clearance crossing at separated grades and one crossing at grade of the tracks of Southern Pacific Company and Camino, Placerville and Lake Tahoe Railroad Company. It appears that the overall project is in the interest of the motoring public, pedestrians and the railroads.

Decision No. 48193 in original Application No. 33841 is hereby revoked.

Width of all crossings shall be substantially as shown in Exhibit "B" Revised March 24, 1953 with the exception of Locations Nos. 12 and 15, which shall be constructed 24 feet in width.

NOTE: As the Main Street crossing (AH-148.6) is being reconstructed as a one-way off ramp from the freeway, the two No. 3 wigwage shall be located on the north side of the railroad track.

Highway crossing construction shall be equal or superior to Standard No. 2-B of General Order No. 72. Maintenance cost of crossing outside of lines two feet outside of rails shall be borne by the applicant or by the City of Placerville on such crossings as are later turned back to the City's control by the applicant. Southern Pacific Company or Camino, Placerville and Lake Tahoe Railroad Company shall bear maintenance cost between such lines.

Expense of construction, revision and elimination shall be borne in accordance with an agreement now being negotiated between the applicant and the other parties involved, and copy of said agreement shall be filed with the Commission prior to commencing construction.

Should the parties fail to agree the Commission will allocate such costs by subsequent order.

Within thirty days after completion pursuant to this order, applicant shall so advise the Commission in writing. This authorization shall become void if not exercised within three years, unless time be extended or if above conditions are not complied with. Authorization may be revoked or modified if public convenience, necessity, or cafety so require.

Applicant has stated that the bid for the first stages of construction is to be advertised immediately and desires authorization before awarding the bid.

Therefore, the effective date of this order shall be the date hereof.
