O R D E R

IT APPEARING that on September 21, 1953, applicant filed a withdrawal of the application herein which withdrawal was subsequent to the issuance of Decision No. 48827, being an interim opinion and order herein issued July 14, 1953, and the Commission having construed such withdrawal as applying only to that portion of the application which was not considered in said Decision No. 48827,

NOW THEREFORE, IT IS HEREBY ORDERED that:

1. The interim order of Decision No. 48827 be and it is hereby made final;
2. Applicant shall file with this Commission, within thirty days after the effective date of this order, in conformance with the provisions of General Order No. 96, four copies of a tariff service area map;
3. Applicant shall file with this Commission, within forty days after the effective date of this order, four copies of a comprehensive map drawn to an indicated scale not smaller than 600 feet to the inch, delineating by appropriate markings the tract of land and the territory served and the location of property of the applicant, and

4. Except to the extent granted by the order in said Decision No. 48827, the application herein is dismissed without prejudice.

The effective date of this order shall be twenty days after the date hereof.
