ORDER REVOKING OPERATIVE RIGHTS

It appearing by Decision No. 44210, dated May 23, 1950, in Application No. 31048, that Eugene V. Myers was authorized to establish and operate a service as a passenger stage corporation for the transportation of passengers and baggage between the City of El Centro and the Western Air Lines' hangar at the El Contro Naval Air Station, and by Decision No. 44731, dated August 29, 1950, in Application No. 31536, that the same Eugene V. Myors was authorized to establish and operate a service as a highway common carrier for the transportation of general commodities having an immediately prior or subsequent aerial movement by Western Air Lines between the City of El Centro and the Western Air Lines: hanger at the El Centro Naval Air Station; it further appearing that no evidence of adequate protection against liability imposed by law for the payment of damages for personal injury or property damage is now on file with the Commission by said Eugene V. Myers, as required by General Orders Nos. 100 and 101; and it further appearing that the

above-described operations have been discontinued for a substantial period of time without any authorization to suspend or discontinue same; therefore, it is found that Eugene V. Myers is no longer conducting and has unlawfully abandoned said passenger stage and highway common carrier operations.

Good cause appearing, IT IS ORDERED that the certificates of public convenience and necessity issued to Eugene V. Myers by Decisions Nos. 44210 and 44731 in the above-entitled proceedings are hereby revoked and all tariffs and timetables on file in the name of Eugene V. Myers are hereby canceled.

The Secretary of the Commission is hereby directed to cause a certified copy of this order to be served upon Eugene V. Myers.

The effective date of this order shall be the twentieth day after service of a copy hereof upon Eugene V. Myers, unless said Eugene V. Myers before such effective date shall have filed with this Commission a written response to this order, denying the facts set forth herein and requesting a public hearing thereon, in which event the effective date of this order will thereby be stayed until hearing is held and further order issued.
