SUPPLEMENTAL OPINION AND ORDER

Minimum rates, rules and regulations for the transportation of property within and between the Cities of Oakland, Alameda, Albany, Berkeley, Emeryville and Piedmont are set forth in City Carriers' Tariff No. 2-A - Highway Carriers' Tariff No. 1-A (Appendix "A" to Decision No. 41362 as amended). The drayage area is divided into zones for rate-making purposes. The zones and their boundaries are described in Items Nos. 40, 50 and 60 series of the tariff. They have been revised from time to time in accordance with the requests of interested parties and as the need therefor has arisen. The last revisions were made November 10, 1951 (Decision No. 46286 in Cases Nos. 4108 and 4109).

The Oakland Chamber of Commerce and the Draymen's Association of Alameda County now seek a further revision of the zone boundaries. The area involved is south of the Southern Pacific Company's right-of-way (Railroad Avenue) and between 50th Avenue and the Oakland-San Leandro boundary line. It is presently located in outer Zone 2. The revision would place it in inner Zone 1. Petitioners point out that the area involved is Oakland's last large undeveloped industrial area. They allege that development of the area has been hindered by the existing zoning arrangements.

They assert that the proposed zone modification would remove this obstacle and encourage industrial development. This would also result, they claim, in additional traffic and revenue for the draymen.

In the circumstances, it appears that this is a matter in which a public hearing is not necessary and that the proposed revisions are justified.

Therefore, good cause appearing,

IT IS HEREBY ORDERED that City Carriers' Tariff No. 2-4 - Highway Carriers' Tariff No. 1-A (Appendix "A" of Decision No. 41362 as amended) be and it is hereby further amended by incorporating therein to become effective November 30, 1953, the following revised pages attached hereto and by this reference made a part hereof.
