O P I N I O N

In the above-entitled application, Pacific Greyhound Lines requests the Commission to redscribe all of its present urban routes within the City of Santa Ana.

Under applicant's proposal it would operate over North Main Street between Washington Street and Second Street instead of over Washington and Spurgeon Streets. It also proposes to operate over Third Street and Second Street between North Main Street and Spurgeon Street instead of over Third Street between Spurgeon Street and Lacey Street. Operations would be continued over Spurgeon Street between Third Street and First Street. Applicant's present use of Washington Street between Spurgeon Street and Tustin Avenue as an alternate route would be discontinued and Seventeenth Street between North Main Street and Tustin Avenue would be used instead.

In support of the request, applicant states that the residents along its presently authorized routes, particularly those residing on Spurgeon Street, have complained with regard to use of that street by applicant. As a result of these complaints, conferences were held between agents of applicant and officials of the City of Santa Ana and it was determined that the routes proposed by applicant would satisfactorily meet the objections of residents in Santa Ana and the city officials. Applicant's present fares and schedules of service will apply to the proposed new routes.

After full consideration, the Commission finds that public convenience and necessity require the establishment and operation of passenger stage service over the proposed reroutings which will be authorized. No protest to the application has been received and it will be granted. No public hearing appears to be necessary.

O R D E R

An application having been filed and the Commission being fully informed therein,

IT IS ORDERED:

(1) That a certificate of public convenience and necessity is hereby granted to Pacific Greyhound Lines authorizing the establishment and operation of service as a passenger stage corporation, as defined in Section 226 in the Public Utilities Code, for the transportation of passengers, baggage and express between the points and over the routes described and numbered UR-16.01 to UR-16.04, both inclusive, as set forth in First Revised Page 83 attached hereto and marked Appendix A.

(2) That Pacific Greyhound Lines is hereby authorized to discontinue passenger stage service over the routes bearing the numbers UR-16.01 to UR-16.04, both inclusive, as presently described in Original Page 83 of Appendix A attached to Decision No. 47907.

(3) That Appendix A of said Decision No. 47907, Application No. 31883, is hereby amended by incorporating therein First Revised Page 83, which is attached hereto and marked Appendix A.

(4) That the operative authority granted in paragraph (1) of this order is consolidated with and made a part of the operative

rights created by said Decision No. 47907 and is subject to all of the provisions therein set forth.

(5) That within thirty days after the effective date hereof applicant shall file appropriate and satisfactory maps with the Commission, delineating the authority herein granted.

The effective date of this order shall be twenty days after the date hereof.

- *UR-16.01 - From the northern city limits of Santa Ana, over U. S. Highway 101 to North Main Street to Second Street to Spurgeon Street to its junction with Third Street.
- *UR-16.02 - From the junction of Third Street and North Main Street, over Third Street to its junction with Spurgeon Street.
- *UR-16.03 - From the junction of Second Street and Spurgeon Street, over Spurgeon Street to First Street to U. S. Highway 101 to the eastern city limits of Santa Ana.
- *UR-16.04 - From the junction of North Main Street and Seventeenth Street, over Seventeenth Street to Tustin Avenue to its junction with U. S. Highway 101, to be operated as an alternate route.
