O P I N I O N

In the above-entitled application Percy L. Musser states that he desires to continue business as a motor transportation broker for which he had obtained a license from the Commission by Decision No. 48040 dated December 9, 1952, in Application No. 33738. License certificate No. 2 issued pursuant to that decision expired December 31, 1953.

Applicant asserts his brokerage business would be continued at 4041 Williams Street, Eureka, California. He plans to continue as a broker for the seven truck carriers served during 1953 and desires also to act as a broker for eighteen additional truck carriers.

Applicant has on file with the Commission a bond required by the provisions of Section 4838 of the Public Utilities Code. After full consideration of applicant's request it appears that the license should be renewed for the remainder of the year 1954. A public hearing appears to be unnecessary.

O R D E R

An application therefor having been filed and good cause appearing,

IT IS ORDERED:

(1) That a license is hereby granted to Percy L. Musser during the remainder of the year 1954 to act as a motor transportation broker, as defined in Section 4803 of the Public Utilities Code, subject to the following conditions:

- (a) That said licensee shall keep his license certificate as a motor transportation broker posted at his authorized places of business so that it is readily available to public inspection at all times.
- (b) That said licensee shall do business as a motor transportation broker only at 4041 Williams Street, Eureka, until otherwise authorized by the Commission, and for motor carriers hereinafter named, or for whom he may hereafter from time to time be permitted to do business by any subsequent order or orders of the Commission.

(2) That the license of said applicant shall authorize him to sell, offer for sale, negotiate for, furnish or provide transportation of property over the public highways of this state, said transportation to be rendered only by the following:
