## <u>OPINION</u>

Leonard H. Guest and Russell T. Smith seek a certificate of public convenience and necessity authorizing them to operate as a passenger stage corporation within and in the immediate vicinity of the City of Salinas, County of Monterey.

Applicants allege that the area, authority to serve which is sought herein, was served by Robb's Transportation Company until December 31, 1953, the effective date of Decision No. 49468 in Application No. 34898; that such decision authorized Bruce W. Robb to discontinue passenger stage service within such area and revoked his operative rights therefor; that there is presently no passenger stage service within such area.

Applicants further allege that they propose to render service once each hour and more frequently if possible; that they propose a single 15-cent fare.

The application indicates that Leonard H. Guest has had experience in conducting the operation of a passenger stage corporation and that he and Russell T. Smith possess the requisite financial ability to inaugurate and maintain the proposed service.

Upon consideration of the facts, here involved, the Commission is of the opinion and hereby finds public convenience and necessity require that the application be granted.

(c) Subject to the authority of this Commission to change or modify them by further order, applicant shall conduct operations pursuant to the certificate herein granted over and along the following routes:

## Route 1:

Beginning at the corner of Salinas and West Alisal, proceeding East on Alisal to the intersection with Williams Road, East on Williams Road to Garner Avenue, North to Towt, East to Del Monte, North to Sanborn Road, West to Garner, South to Towt, West to East Market, West to Madeira, South to East Alisal, and West to point of beginning.

## Route 2:

Beginning at Salinas and West Alisal, thence North to Gabilan, West to Lincoln, North to West Market, North to an unnamed street, East to North Main, North to East Laurel Drive, East to Tapadero, North to Curtis, West to Tyler, South to Laurel Drive, West to Hyland, thence East on Laurel Drive to North Main, South to West Market, West to Lincoln, South to Alisal, East to Salinas, South to Clay, East to Main, South to Romie Lane, West to Valley Center Parking Lot, thence returning East on Romie Lane to Main, and North to point of beginning.

The effective date of this order shall be ten days after

the date hereof.
