O P I N I O N

San Diego Transit System, a passenger stage corporation operating a bus service in San Diego and vicinity, by this application seeks authority to make two short extensions for the purpose of serving new residential areas. The application is supported by a resolution of the San Diego City Council, Resolution No. 115812. One extension is .4 of a mile in length, and the other is .7 of a mile long. In addition to serving new areas, the proposed route is an improvement over the present operation insofar as turnaround facilities are concerned.

The application is not protested.

No new equipment will be necessary and no changes in schedules or fares are contemplated.

The Commission having considered the matter is of the opinion and finds that public convenience and necessity require that this application be granted. Public hearing is not necessary.

O R D E R

Application having been made, the Commission being fully advised in the premises and having found that public convenience and necessity so require,

IT IS ORDERED that the route description of Route "5", appearing in Decision No. 48447, on Application No. 34125, be and it is hereby amended to read as follows:

Beginning at the intersection of Clairemont Drive and Clairemont Mesa Boulevard, outbound along Clairemont Mesa Boulevard, Luna Avenue to the intersection of Luna Avenue with Jutland Drive; returning via Jutland Drive, Idlewild Way, Moraga Avenue, Clairemont Mesa Boulevard, Clairemont Drive, Burgener Boulevard, Cloverdale Street, Milton Street, Morena Boulevard, Taylor Street, San Diego Avenue (La Jolla Avenue), California Street, Winder Street, India Street, Laurel Street, State Street, B Street, Fifth Avenue, Market Street, 45th Street, Hilltop Drive, 47th Street, Federal Boulevard, Euclid Avenue, 54th Street, Streamview Drive, College Avenue, Radio Road, Vista Grande Drive, Hoffman Avenue, and Massachusetts Avenue to University Avenue.

Temporary Route: Along Morena Boulevard and Clairemont Drive (name changed from Huxley).

Also beginning at the intersection of 54th Street and Streamview Drive, thence along 54th Street to Collier Avenue.

The effective date of this order shall be ten days after the date hereof.
