## OPINION

The applicant seeks an extension of its highway common carrier operative rights to include Point Arena Weather Station, which would become an off-route point on applicant's present service between Jenner and Rockport along State Highway No. 1.

Applicant has served the Jenner-Rockport area for many years. The application recites that, so far as applicant knows, there is no carrier authorized to serve between Point Arena Weather Station and the points now served by applicant.

Applicant is an experienced and successful carrier who has long operated in the general area, and has the necessary equipment and financing to perform the service which it is here requesting:

In our opinion, public convenience and necessity require that the sought extension of operative rights be granted.

## ORDER

The Commission having considered this matter and being of the opinion that a public hearing is not necessary and finding that public convenience and necessity so require, therefore,

## IT IS HEREBY ORDERED:

- (1) That a certificate of public convenience and necessity is hereby granted to Willig Freight Lines authorizing the establishment and operation of a service as a highway common carrier, as defined in Section 213 of the Public Utilities Code, for the transportation of general commodities except uncrated household goods and other commodities/for which the Commission has prescribed minimum rates in City Carriers' Tariff No. 3-A, Highway Carriers' Tariff No. 4-A (Appendix "A" to Decision No. 44919, as amended) and petroleum products in bulk, between all points now served by Willig Freight Lines as a highway common carrier, on the one hand, and Point Arena Weather Station, on the other hand.
- (2) In providing service pursuant to the certificate herein granted, applicant shall comply with the following service regulations:
  - (a) Within thirty days after the effective date of this order, applicant shall file a written acceptance of the certificate herein granted.
  - (b) Within sixty days after the effective date hereof, and upon not less than five days' notice to the Commission and the public, applicant shall establish the service herein authorized.
  - (c) Within sixty days after the effective date of this order, upon not less than one day's notice to the Commission and the public, applicant shall supplement or reissue its tariffs now on file with the Commission so as to establish rates,

rules and regulations applicable to the service herein authorized and make the same effective con-currently with the establishment of service hereunder.
