## SUPPLEMENTAL OPINION AND-ORDER

Decision No: 49893 of April 6, 1954, in this proceeding, established revised territorial group descriptions in City Carriers' Tariff No. 5 - Highway Carriers' Tariff No. 6 for the transportation of petroleum and petroleum products in bulk. The decision provided for later inclusion of maps of the territorial groups. The maps are now ready. They will be incorporated in the tariff.
























