## ORDER MODIFYING THE ORDER OF DECISION NO. 48038

Decision No. 48038 was rendered by this Commission on December 9, 1952, and granted applicant rights to operate via numerous routes in California extending east and south of the City of Los Angeles. The route descriptions were taken from applicant's "Amendment To Application" filed by applicant with this Commission on June 20, 1951. In its "Petition For Correction Of Order In Decision No. 48038" filed with this Commission on May 12, 1954, applicant alleges that certain route descriptions appearing in the "Amendment To Application" and copied in the said Decision No. 48038 are incorrect and requests that the said decision be changed to correctly designate the routes.

We have compared the route descriptions appearing in Decision No. 48038 with the route map, Exhibit E, attached to the original application, and it appears that certain route descriptions in Decision No. 48038 are incorrect, therefore, in

order to correctly designate the routes authorized for applicant's use by Decision No. 48038,

IT IS ORDERED that Decision No. 48038 be amended as follows:

(1) On Page 17 change the 6th paragraph to read:

"State Highway 71 from its junction with a line lying five miles southwesterly from and parallel to State Highway 18 near Corona, California to its junction with U. S. Highway 66 near Claremont, California."

(2) On Page 18, change the first paragraph to read:

"State Highway 35 from its junction with State Highway 22 near Los Alamitos, California to its junction with U. S. Highway 99 near West Covina, California."

(3) On Page 18, change the third paragraph to read:

"State Highway 15 from its junction with U. S. Highway 101 - Alternate in Long Beach, California to its junction with U. S. Highway 99 near Monterey Park, California, thence along Atlantic Boulevard and Los Robles Avenue in Monterey Park and Pasadena, California to the junction of Los Robles Avenue and U. S. Highway 66."

(4) On Page 18, change the last paragraph to read:

"State Highway 7 from its junction with U.S. Highway 101-A near El Segundo, California to its junction with U.S. Highway 66 near San Fernando, California." A. 31630 (As Amended) - RV

IT IS FURTHER ORDERED that except as herein modified the provisions of Decision No. 48038 shall remain in full force and effect.
