In the Matter of the Application of LOS ANGELES TRANSIT LINES, a corporation, for authority to extend and modify its Hollydale Motor Coach Line No. 51, and to combine the modified line with its South Gate Motor Coach Line No. 63.

OPINION

By the above-entitled application Los Angeles Transit

Lines seeks authority (1) to extend its Hollydale Motor Coach Line

No. 51 along Imperial Highway between its intersections with

Garfield Avenue and Horton Lane; (2) to render service on Line

No. 51 in one direction only over a loop which includes the proposed extension, in lieu of two-way service over all that portion

of the loop which excludes the proposed extension; (3) to consolidate its Line No. 51 and its South Gate Motor Coach Line No. 63

into one line to be known as South Gate Motor Coach Line No. 63.

In support of its application for authority to operate the loop service, applicant alleges that there has been an

The loop will be over the following route: from the intersection of Imperial Highway and Garfield Avenue, via Garfield Avenue, Main Street, Paramount Boulevard, Gounty Farm Drive, Consuelo Street, Eucalyptus Street, Horton Lane and Imperial Highway to Garfield Avenue.

increasing need for a more convenient service to that portion of Rancho Los Amigos immediately north of Imperial Highway and Horton Lane, and that the presently authorized route of the Hollydale Motor Coach Line No. 51 does not permit the most convenient service possible to the Rancho Los Amigos due to lack of adequate turnaround facilities.

Except for the portion of the loop along Garfield Avenue between Imperial Highway and Main Street, and the portion along Imperial Highway between Garfield Avenue and Horton Lane, in the city of South Gate, there is service in both directions by Southern Cities Transit, Inc. There are two local transit lines serving all or a portion of Imperial Highway between Garfield Avenue and Horton Lane. There is no other passenger carrier on Garfield Avenue, but most homes or business establishments on Garfield Avenue are within two to three blocks of Main Street which will be served in both directions by Southern Cities Transit, Inc.

The City of South Gate, the only city through which all or a portion of the proposed extension runs, has indicated that it has no objection to the proposal.

Upon the allegations of the verified application and the records of this Commission concerning existing passenger stages in the Hollydale area of the City of South Gate and the County of Los Angeles, of which we take judicial notice, we find that public convenience and necessity require that applicant extend its services as proposed in the application herein. The requested authority will be granted. A public hearing is not necessary.

(3) That Los Angeles Transit Lines may consolidate its
South Gate Motor Coach Line No. 63, as described in Decision
No. 43893, dated March 7, 1950, on Application No. 30951, with
its Hollydale Motor Coach Line No. 51, as described in Decision
No. 39103, dated June 18, 1946, on Application No. 19179, 68th
supplemental, and the extension authorized by ordering paragraph
(1) of the order herein, into one line to be known as South Gate
Motor Coach Line No. 63 which shall operate over the following
route:

South Gate Motor Coach Line No. 63.

From Seville Avenue and Palm Place (City of South Gate), thence via Seville Avenue, Long Beach Boulevard, Firestone Boulevard, Santa Fe Avenue, Truba Avenue, Tweedy Boulevard, Atlantic Avenue, Imperial Highway, Garfield Avenue, Main Street, Paramount Boulevard, County Farm Drive, Consuelo Street, Eucalyptus Street, Horton Lane and Imperial Highway to Garfield Avenue; and returning via Imperial Highway, Atlantic Avenue, Tweedy Boulevard, Truba Avenue, Santa Fe Avenue, Firestone Boulevard, Long Beach Boulevard and Seville Avenue to Seville Avenue and Palm Place (City of South Gate).

Also from Seville Avenue and Palm Place (City of South Gate), thence via Seville Avenue, Santa Ana Street, State Street, Firestone Boulevard, California Avenue and Century Boulevard to Imperial Highway (City of Lynwood); and returning via the reverse of the above.

Also from Seville Avenue and Palm Place (City of South Gate), thence via Seville Avenue, Liberty Boulevard, Otis Avenue, Firestone Boulevard, Annetta Avenue, Southern Avenue and Alexander Avenue to Abbott Road (City of Lynwood); and returning via reverse of the above.

Applicant is authorized to turn its motor vehicles at termini and intermediate points, in either direction, at intersections of streets or by operating around a block contiguous to such intersections, or in accordance with local traffic rules.

(4) At least 10 days prior to the inauguration of service pursuant to this order applicant shall post plainly visible notices in all its stages and terminals used in such service. Such notices shall remain posted for at least 10 days prior to the changes authorized by paragraphs (1) and (3) of this order.
