FIRST SUPPLEMENTAL OPINION AND ORDER

Applicant was granted a license by Decision No. 49868, issued March 30, 1954, to act as a motor transportation broker for eight carriers.

By his First Supplemental Application applicant requests authorization to act as a broker for an additional group of sixteen carriers. Letters of authority from each of said carriers, designating applicant as broker, are annexed to the supplemental application.

Upon consideration of the First Supplemental Application herein, we conclude that the requested authority should be granted. A public hearing is not necessary.

Therefore, good cause appearing, IT IS ORDERED that ordering paragraph 2 of Decision No. 49868 be and it is hereby amended to include the following carriers for whom applicant is hereby authorized to sell, offer for sale, negotiate for, furnish or provide transportation of property over the public highways of this state:
