## ORDER REVOKING OPERATIVE AUTHORITY

It appearing by Decision No. 41460 dated April 13. 1948, pursuant to Application No. 29209, Charles Manfre, doing business as Watsonville Transit System was authorized to establish and operate a service as a passenger stage corporation for the transportation of passengers between Watsonville and Freedom, Interlaken and Pajaro and intermediate points; that by Decision No. 44042 dated April 18, 1950, pursuant to Application No. 31285, Charles Manfre, doing business as Watsonville Transit System was authorized to sell and transfer the aforementioned operating rights to Charles Manfre Transportation Co., Inc.; that since July 18, 1954 Charles Manfre or Charles Manfre Transportation Co., Inc., has had no evidence of adequate protection against liability imposed by law for the payment of damages for personal injury or property damage on file with this Commission, as required by General Order No. 101; and that the passenger stage service in question has been discontinued for a substantial period of time without any authorization to suspend or discontinue such operation. Therefore, it is found that Charles Manfre and/or Charles Manfre Transportation Co., Inc., is no longer conducting and has abandoned said passenger stage operation.
